The officer will support the organization in;

- Develop data collection tools for different project implemented by the organization ensuring that the
 tools capture both qualitative and quantitative data.
- Liaise with the technical officers to develop terms of references for different surveys and data collection activities of the organization.
- Working together with other officers to ensure that all the baselines, assessments, studies and evaluations.
- Supporting other project officer in developing data collection tools for routine monitoring purposes.
- Supervising all data collection activities for the assigned projects.
- Leading other staff in analysing data collected from the field and work together in development of reports from these analyses.
- Taking part in the joint monitoring activities and ensure that all the action plans from the joint monitoring are acted upon.
- Ensuring that data is available both to donors, other stakeholder and the organization to inform on progress against the objectives
- Taking lead in beneficiary accountability ensuring that the organization's accountability plan is implemented and that the beneficiaries' voices are heard and included in all the projects being implemented by the organization.
- Take lead in developing information sharing and feedback framework and relevant tools for the organization.
- Work with project officer and field-based staff to carry out routine information sharing, collection and action on complaints and feedback for the organization.
- As the secretary to the feedback committee, ensure that all the community feedback is documented and acted on in a timely manner.
- Ensuring that the learnings from the projects are documented and are used in future programming.
- Supporting in proposal development by coming up with M&E plans and any other information needed during proposal development

- At least an undergraduate degree or diploma in any of the following fields; Monitoring and Evaluation, applied statistics, sociology or anthropometry, education or any relevant training
- A professional training in monitoring and evaluation is a plus
- Experience in monitoring and evaluation in a national or international organization for at least 2 year
- Knowledge or experience in data collection using mobile phones
- Strong computing skills especially in spreadsheets
