Suppliers sending their offer by E-mail only will be requested to submit original offers at a later stage if their offer is pre-selected.
- 3. Bidders are requested to fill in, sign, stamp and return all pages of instructions to bidders, financial and technical offer forms, bidder's questionnaire, ethical declaration, general conditions for purchase and bidder's checklist according to ACTED format below.
- 4. The tender opening session will take place on 28/01/2022 at 4:00PM (South Sudanese local time) in ACTED Juba Office. Suppliers can request to attend the opening session on Skype. Suppliers must inform ACTED at least 24 hours' prior the opening session and must provide both their email and their skype username. This date may be subject to change.
- 5. The offer to the call for tender will not result in the award of a contract
- 6. Unsealed envelope and late offers will not be considered.
- 7. To ensure that funds are used exclusively for humanitarian purposes and in accordance with donors' compliance requirements, all contract offers are subject to the condition that contractors do not appear on anti-terrorism lists, in line with ACTED's anti-terrorism policy. 1. About ACTED

ACTED is a non-governmental organization with headquarters in Paris, founded in 1993. Independent, private and not-for-profit, ACTED respects a strict political and religious impartiality and operates according to principles of non-discrimination and transparency.

- 5. Proven previous experience with NGOs, INGOs, UN agencies and embassies will be considered highly advantageous.
