Description:

This consultancy is to develop a contextualized legal literacy and sensitization training guide for Jonglei JLO actors in Jonglei State. The guide will be designed to enhance their understanding of the legal system, human rights, and conflict resolution mechanisms.

Scope of Work:

- Conduct a desk review of existing legal literacy and sensitization materials, including those developed by UNMISS, local CSOs, and international organizations.
- Undertake a field visit to Jonglei State to gather first-hand information on the legal needs and challenges faced by JLO actors.
- Develop a contextualized legal literacy and sensitization training guide that addresses the specific needs and challenges of JLO actors in Jonglei State.
- Incorporate illustrations and other visual aids to enhance the accessibility and effectiveness of the training guide.
- Pilot test the training guide with a group of JLO actors in Jonglei State to assess its relevance, clarity, and effectiveness.
- Revise the training guide based on feedback from the pilot test and finalize it for wide dissemination.
- Prepare and submit a comprehensive report that includes the methodology used, findings from the desk review and field visit, the training guide, and recommendations for future trainings.



The consultant will work with ZOA-Dorcas staff to carry out this assignment.
