4.0 PREQUALIFICATION INSTRUCTIONS

The CAFOD in South Sudan hereinafter referred to as "procuring entity" intends to prequalify Suppliers/Service Providers for the supply and delivery of goods and services based on the categories provided in Part A and B.

Prequalification is open to eligible Suppliers/ Service Providers as indicated in the instructions.

5.0 PRE-QUALIFICATION OBJECTIVE

The main objectives of this part are to qualify potential Suppliers/Service Providers to supply goods and services under the relevant tenders/quotations and proposals as and when required during the period ending 31st March 2023.

5.1.0 LANGUAGE

All the information requested for pre-qualification shall be provided in the English language.

5.1.1 EXPERIENCE

Prospective Suppliers/Service Providers must have carried out successful supply and delivery of similar goods/services to institutions of similar size and complexity.

5.1.2 TERMS AND CONDITION - APPENDIX 2.

Eligible and interested Suppliers/Service Providers shall be required to read and be willing to abide to the CAFOD purchase order terms and conditions, CAFOD Supplier Code of Conduct and CAFOD Supplier Questionnaires indicated in appendix 2.

5.1.3 ELIGIBLE SUPPLIERS/SERVICE PROVIDERS

The procuring entity's employees and their relative (spouse and children) are not eligible to participate in the pre-qualification process.

CAFOD reserves the right to request the submission of additional information from prospective Suppliers/Service Providers.

5.1.7 INVITATION TO TENDER/QUOTATION

Bidding documents (Tender/Quotation) will be made available only to those bidders whose pre-qualification documents are accepted by the CAFOD after the completion of the pre-qualification process ONLY when that particular need arrive or available to be procured.

5.1.8 NOTIFICATION OF SUCCESSFUL AND UNSUCCESSFUL SUPPLIERS OR SERVICE PROVIDERS

CAFOD will only notified the successful bidders/Suppliers/Service Providers for prequalification outcome in writing, and this will be done after due diligence process completed for successful bidders.

6.0 PRE-QUALIFICATION GUIDELINES/REGULATIONS AND CRITERIA

6.1.0 INCOMPLETE APPLICATION

The application forms which are not filled and duly stamped and submitted in the prescribed manner will not be considered by the reviewing committee mandate to carry out this exercise.

6.1.1 THE PRE-QUALIFICATION DATA

It is understood and agreed that the pre-qualification data of the prospective Suppliers/Service Providers is to be used by CAFOD in selection of prospective firm to perform in respect categories as described by the client.

6.1.2 QUALIFICATION REQUIREMENTS

Prospective Suppliers/Service Providers will not be considered qualified unless in the judgment of CAFOD they possess the capability, experience, qualified personnel, available and sustainable equipment, and net current assets or working capital enough to satisfactorily execute the contract for goods/services.

7.0 ESSENTIAL CRITERIA FOR PRE-QUALIFICATION

7.1.0 EXPERIENCE

The prospective bidder shall have at least three (3) years' experience in the supply of goods, services, and allied items. Past performance will be shown by way of attaching relevant local purchase orders (LPOs)/contract agreement, Completion certificates and letters of recommendations. Suppliers/Service Providers should further specify the area of specializations.

Prospective suppliers should have special experience and capability to organize, supply and deliver items or services at short notice.

7.1.1 FINANCIAL CONDITION

The supplier's financial condition will be determined by latest audited financial statements submitted with the pre-qualification documents as well as bank statement for the last six (6) months. Reference letters from the bank should also be provided as a proven of financial viability. Potential Suppliers/Service Providers will be pre-qualified on the satisfactory information given.

7.1.2 DECLARATION – APPENDIX 1

Application MUST include a declaration Appendix 1 certifying the accuracy for the information given.

7.1.3 WITHDRAWAL OF PRE-QUALIFICATION

CAFOD has the right to reject the tender from a pre-qualified firm, should a condition arise between the time the firm has tendered and the bid opening date which in the opinion of the CAFOD could compromise the performance and but not limited to bankruptcy, change in ownership or new commitment.
