INTRODUCTION

The project is intended to provide emergency lifesaving services to about 550 Households (3,300 individuals) who have been severely affected by the devastating drought that hit parts of Kapoeta East county of Eastern Equatoria state. IRSS proposes 6 months lifesaving interventions through two rounds of emergency food distribution. The overall objective of this intervention is to enhance gender-responsive relief assistance to displaced people and host communities in Kapoeta East (Eastern Equatoria (EE)). The project will among others provide two rounds of food parcels (comprising of 90kg Sorghum, 10kg beans, 3litres cooking oil, 1kg salt) to 550 HHs. This life saving emergency response will help to contribute to food security of the affected households.

Under Protection, numerous stakeholders (women and youth led CBOs, representatives of people with disabilities, community and religious leaders and government officials) will be trained on GBV & gender equality, and protection related issues. We will organize awareness sessions for target communities on GBV & gender equality, and protection related issues.

A total of 5,000 individuals (1,350 men, 1,750 women; 650 boys, 1,250 girls, including 749 living with disabilities) will be reached through an inclusive approach targeting the most vulnerable within the project communities (IDPs, returnees and host communities).
