Action Against Hunger-USA is part of the Action Against Hunger International network, which provides humanitarian relief in over 40 countries worldwide in the sectors of nutrition, health, water/sanitation, and food security. Action Against Hunger-USA, an independent NGO, currently manages operations in seven countries: Kenya, South Sudan, Tanzania, Uganda, Ethiopia, Haiti and Somalia. Action Against Hunger-USA has approximately 1,500 staff based in the various country offices, Head Quarter in New York City and Operational Centre in Nairobi. Additional growth is anticipated.

I. SUMMARY OF POSITION:

The GBV Research Program Manager will be responsible for overseeing implementation of the GBV risk mitigation package the GBV RM intervention package as part of the GBV/Nutrition study being implemented by Action Against Hunger South Sudan, Ministry of Health, UNICEF and other partners. The Program Manager should have good judgement and problem-solving skills and strong communication skill, as well as, well-developed interpersonal skills (to be able to develop good rapport with data collectors and other in-country stakeholders) and have at least some familiarity with Community-based Management of Acute Malnutrition (CMAM) programming.

PURPOSE:

The position is responsible for providing technical and strategic support to Action Against Hunger South Sudan Mission specifically through effective implementation of the GBV Risk Mitigation Intervention Package for a period of six months. S/he will report directly to the Head/ Deputy Head of Health and Nutrition and also liaise closely with the AAH Research Coordinator and the UNICEF team on regular basis.

ENGAGEMENT

Develop collaborative working relationships with program and support teams at the national and county level to ensure effective implementation of the intervention package.





DELIVERY

The key deliverables will include:

- Create a detailed plan and timeline for implementation of the GBV risk mitigation
- Ensure effective and efficient implementation of the GBV risk mitigation package according to
- Deliver trainings on GBV risk mitigation and responding to disclosures, including follow-up monitoring and refresher trainings as needed
- Identify concrete entry points to strengthen referrals between nutrition services and GBV
- Ensure in-person technical support is available to every implementation site included in the study (at least one in-person visit per month conducted by either/both ACF or UNICEF GBV
- Support GBV-related components of enumerator training ahead of endline data collection
- Conduct validation/feedback sessions to review endline data with enumerators, frontline nutrition staff, community members and government counterparts in the targeted locations
- Support the study's core planning team with analysis and interpretation of endline data.

11. **ESSENTIAL JOB FUNCTIONS**

- Act as the GBV technical lead within ACF on the GBV/Nutrition study
- Coordinate with ACF nutrition staff and GBV implementing partners in targeted locations to identify opportunities for additional programmatic collaboration and troubleshoot challenges as needed (for example, in relation to disclosures/referrals)
- Work closely with ACF Research Coordinator to ensure GBV risk mitigation monitoring data needed for the study is compiled and available for analysis
- Participate in regular calls with other GBV technical focal points in the study (from UNICEF South Sudan, ESARO and HQ team)
- Participate in check-in calls with the study's "core planning team" (UNICEF, ACF and Kenyatta
- Work directly with the GBV focal point from UNICEF South Sudan to ensure Ministry of Gender and the GBV sub-cluster receive regular updates on progress of the study (national
- Provide weekly status updates in writing to the ACF Nutrition Manager and UNICEF GBV technical team for the project.
