VACANCY ANNOUNCEMENT FOR THE POSITION OF WASH ENGINEER

Coalition for Humanity (CH) is a National NGO registered in South Sudan with experience in implementing humanitarian and resilience projects. The organization focuses on Food Security and Livelihoods (FSL), Water, Sanitation and Hygiene (WASH), Gender Based Violence (GBV), General Protection (GP), Health and Nutrition. Coalition for Humanity has experience in integrating projects and forming a nexus across sectors in order to leverage on resources. We consider Protection/GBV, Housing, Land and Property rights (HLP) governance, peace building and conflict transformation as cross cutting issues. We have successfully integrated these in WASH, FSL, Non-food items, Health and Nutrition. Coalition for Humanity has its headquarters in Juba but with presence in the Upper Nile counties of Longenchuk, Maiwut, Ulang, and Nasir. CH operates in Jonglei with presence in Ayod, Pibor and Twic East counties and Unity State with field offices in Leer, Panyijiar, Pariang, Mayendit, Koch, Rubkona and Mayom counties. Position description

Job title: WASH Engineer

Job Location: Based in Leer with flexibility to Rove within other field locations in project areas.

Reports to: Project Manager

Job Summary

The WASH Engineer shall plan, develop, monitor and evaluate the assigned WASH & SN/FI project(s). This involves assessing WASH needs, proposing appropriate interventions and timely responding to the needs, and initiating and effectively managing and reporting on the projects in line with the objectives, timeframe and budget. The position holder shall also provide technical support to durable solutions through shelter programming within CH. Providing technical support, leadership and strategic direction to other project staff as shall be assigned.

Other important aspects of the role include meeting quality standards in WASH delivery, encouraging beneficiary participation, liaising with other stakeholders and managing and training WASH staff

Key duties/Responsibilities

- Prepare Bills of quantity (BOQS) for all construction and rehabilitated works.
- Design innovative and cost-effective WASH facilities in line with prevailing environmental and climate conditions.
- Act as Coalition for Humanity point of reference and expert with WASH and ESNFIs clusters.
- Rehabilitation and repairs of boreholes and other water points liaising with authorities and partners
- Knowledge of operating a drilling rig and training other is required.
- Participate in borehole drilling and construction, both manual/rig drilling machine.
- Take accurate borehole log sheet and keep an update record.

- Degree in civil engineering, water engineering or diploma with considerable years of experience is desirable from reputable University.
- 3 years' post-qualification professional experience in a humanitarian/recovery context and specific experience in one or more Core Competencies: WASH, Shelter/NFI.
- Proven experience of drilling and rehabilitation of boreholes. Experience with India Mark II will be an added advantage
- Experience working in complex and volatile contexts desirable.
- Experience in protection mainstreaming, desirable.

- Skills and experience in conducting water quality analysis using portable water testing kits.
- Technical expertise in WASH and S/NFI will be advantageous.

- Ability and willingness to manage project implementation.
- Good understanding of Shelter/NFI in emergencies, rehabilitation and kits distribution.
