Background and Justification:	

JSI Research & Training Institute, Inc. (JSI) is a public health management consulting and research organization dedicated to improving the health of individuals and communities throughout the world. For the past 40 years, we have been providing technical and administrative assistance to health programs around the world. JSI R&T implements projects in more than 107 countries.

In South Sudan, JSI provides technical support in delivery of quality immunization services to the National Ministry of Health.

COVID-19 was declared a public health emergency of International concern on 30th January 2020. While South Sudan reported its first case of COVID-19 pandemic on 5th April 2020, the epidemiological reports now indicate more than 12,000 confirmed cases, and over 130 COVID-19 related deaths in South Sudan. Globally, more than 3 million died.

Key public health interventions to prevent the spread of the virus include: social distancing, wearing a face mask and hand sanitizing. In February 2021, WHO approved the AstraZeneca vaccine under Emergency Use Listing (EUL) to mitigate community transmission and reach herd immunity. Such development and deployment of COVID-19 vaccines and the successful implementation of national public health campaigns have reduced morbidity and mortality due to COVID-19 infection. More than 194 countries have deployed the vaccine and immunized the population with the first and second dose of the vaccines.

South Sudan MoH approved deployment of AstraZeneca vaccine from Oxford University as an important tool to reduce mortality and morbidity due to COVID-19 infection.

JSI developed and adopted COVID-19 training materials using WHO training guidelines with technical support from UNICEF, HPF and MoH.

However, during first training of Health workers in Juba Teaching Hospital in preparation for National launch, it was observed that around 10% of health workers had a language barrier (Arabic), and hence could not read or write English. Therefore, JSI is seeking to hire consultancy services of a self-driv





motivated professional to translate training and IEC materials adopted by MoH for COVID-19 vaccination in the country for health workers in Arabic language in South Sudan.

Purpose and objectives of the consultancy provision:

The purpose of this consultancy position is to translate MoH COVID-19 related materials, including tools. The Overall objectives include:

- Engaging with the leadership of MOH and partners to interpret the training materials developed for COVID-19 vaccination and messaging in the country
- Translating the materials from English to Arabic
- Increasing acceptance and use of COVID-19 materials by all categories of health workers

The consultant is expected to provide technical inputs in translation and interpretation of COVID-19 related materials adopted by MoH and WHO in South Sudan through document review and consultative meetings with MoH leadership, as well as JSI.
