Background



Tasks and Responsibilities:

- Providing driving services for the project staff and others involved as instructed by the Project Coordinator
- Checking the basic maintenance (oil, coolant, water, tires pressure, battery water regularly
- Maintain a daily log of all trips, mileage and fuel consumption for monthly checking by the line manager
- Completes the information required for monthly vehicle reports to be submitted to the line manager
- Ensuring that all major incidences are reported to the Project Coordinator immediately
- Ensuring that project vehicles serviced in good time when faults emerge
- Ensuring that the vehicles are clean at all times
