Christian Missionaries initiative (CMI) is, non-governmental, nonprofit making, none discriminating, non-political Christian relief organization that was established by six Missionaries in 2007 under the leadership of South Sudanese Missionaries. These intellectuals have unified their human resources to form this NGO, which was meant to help the victims of the war, the refugees and famine affected people to help themselves. Since then, the organization was expanding in all aspects of organizational membership, developmental strategies, and program implementation in the field of Health, Education, Protection (Child protection and Mine Action), Peace building, Civic Education, Human right, Food security and livelihood, Environmental protection, Shelter, and Ministry.

9. Ownership of tenders

10. Opening of submitted tenders.
