The **Government of the Republic of South Sudan, through the Ministry of Water Resources and Irrigation, has received** financing from the World Bank toward the cost of implementation of the **Regional Climate Resilience Program for Eastern and Southern Africa** and intends to apply part of the proceeds toward payments under the contracts for **Complete Rehabilitation of Lupetet and Kalabolyang Haffirs, and Minor Rehabilitation of Nadapal Haffir in Eastern Equatoria State, South Sudan.** For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing,
2. The **Ministry of Water Resources and Irrigation** now invites sealed Bids from eligible Bidders for the **complete rehabilitation of Lupetet and Kalabolyang Haffirs and the minor rehabilitation of Nadapal Haffir, within 120 calendar days located in Eastern Equatoria State, South Sudan.** Bidders may bid for any one or all lots as shown below:

3. Interested Bidders **MUST** state which Lot(s) they are applying to participate. Bidders are free to bid for any or all Lots, subject to them meeting the required Qualification Criteria.
4. There will be no Margin of Preference.

Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers **July 2016, revised September 2025** (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations that meet the following requirements:
 - i. Valid Certificate of Registration or Certificate of Incorporation
 - ii. Valid Trading or Operation License /Permit
 - iii. Evidence of Tax compliance

Bids will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend at the address below on **10.05 hours local time on 31st March 2026**.
