To achieve this objective, Help - Germany implements a multi-sectoral program that includes Food Security & Livelihood, Nutrition, WASH as key activities. Help -Germany currently works closely with the County WASH Departments in large scale county wide WASH and Nutrition programming. Help's Nutrition and Food Security programming is expanding its outreach mechanisms and introducing new initiatives. Help - Germany has program activities in Easter Lakes State.

Objective

To strengthen our technical team, **Help** is looking for a qualified personnel to fill the position of Monitoring, Evaluation and Learning Manager. The MEL Manager will perform his/her duties directly under the Country Director, and be responsible for all monitoring, evaluation and learning for **Help-Hilfe zur Selbsthilfe** (herein referred to as Help). He/she will work closely with the program technical focal points/senior leadership in establishing and maintaining a dynamic and robust MEL framework for measuring Help's impact on the communities we serve.

Key Responsibilities:

- Lead and implement monitoring, evaluation and learning (MEL) for Help, including updating the live MEL framework and strategy.
- Advise the Senior Management Team (SMT) and technical focal points at both program and project levels.
- Develop and supervise the monitoring framework for the program and on-going projects, identifying project and program delivery strengths, weakness and risks.
- Collation of Help's achievement progress and impact against log-frame, including providing key inputs to annual reporting.

- Assist colleagues, including key decision-making bodies such as the project review members, senior management team, etc. accessing and using MEL data and evidence
- Support any independent audit, external evaluation and/or review processes that may be required.
- Lead the implementation, monitoring and reporting of gender, equity and social inclusion and inclusivity strategy for Help South Sudan Program.
- Advise Partner/s on project reporting (technical, results and risk), ensuring reporting meets donor requirements, providing a coordination and quality assurance function.
- Co-ordinate processes on ongoing M&E data gathering and analysis from partner/s
- Support and Help colleagues and engage with MEL activities that include applying assessment tools, designing case studies, implementing capacity building strategies and providing training, assisting with data analysis and presentation, developing data-informed action plans and other technical assistance as requested.
- Facilitate processes to ensure learning is identified and captured across all thematic areas of the program.
- Lead development and management of systems to aggregate and visualize program data, including dashboards, to facilitate data use including analysis for learning and adaptive program management.

Qualifications/Skills:

- Diploma or Equivalent qualification in Development, Social Work or Other Relevant Course
- Knowledge and understanding of the South Sudan Humanitarian context
- Substantial practical experience of designing/delivering humanitarian programs
- Significant MEL experience at national and/or field levels.
- Excellent written, verbal and interpersonal skills with previous experience of developing and delivering MEL plans and activities in a humanitarian, impact-oriented environment in a collaborative manner across a culturally diverse and multi-disciplinary team.
- Ability to work flexibly, and to tight deadlines, maintaining consistently high standards and attention to detail.
- Experience of working collaboratively with a range of external and humanitarian organizations, including UN agencies, community leaders, local authorities at County and State levels, government agencies, and the voluntary and private sectors
- Demonstrated self-starter and able to get to grips with Help's business quickly
- Experience working with the INGO in similar capacity will be an added advantage.
