CEF support education by establishing temporary learning spaces, construct gender segregated pit latrines. CEF train teachers, PTAs, and SMCS. CEF engage communities to increase enrolment in both pre-primary and primary education. CEF establishes caregiver groups, trains school mentors, and conduct school-based campaigns to promote enrolment of out of school. CEF provide dignity kits for adolescent girls, provide scholastic materials (books, mathematical set, pens, schoolbags, and pencils) to the most vulnerable pupils, conduct public awareness campaign for girl child education and BTL.

# Main Duties and Responsibilities. And Empowerment Foundation

- The MSMEs Consultant will facilitate the policy formulation through participate in planning meetings with Income Generating Association (IGA) and key stakeholders.
- Lead the analysis on mapping and identification of the MSMEs (especially food processing sector at company level) with backward and forward linkage.
- Identify and select some MSM groups as "champions" based on their capacity on their linkages/value chain, production capacity, quality control, innovation supplier-buyer
- Prepare lesson-learnt story from selected MSMEs that are selected as champions.
- Collaborate with Industrial Expert to prepare strategies and policy recommendation to strengthen the linkage among the MSMEs from various basic competencies (human resource, marketing, innovation etc.).
- Present the findings and policy recommendations to CEF and other stakeholders.
- Prepare a monthly progress report outlining activities conducted during the period and link to deliverables in the contract, meetings, output produced, and follow up plan for internal reporting purpose.
