#### **TERMS AND CONDITIONS FOR BIDDING.**

**Your bid should clearly indicate the following:**

1. Provide legal required documents of the company as follows;
  - Copy of valid Certificate of tax clearance,
  - Copy of the company's certificate of incorporation,
  - Copy of Chamber of Commerce registration,
  - Copy Tax Identification Certificate,
  - Bank account details preferably where the money would be paid.
  - Copy of Certificate of Operation,
  - Company's official address,
  
2. Price based on the current context and Currency of offer -USD
  
3. Work plan time frame; clearly indicate the number of days required:  
Attach copies of reference list of NGOs/NNGOs for conducted training to farmers how to oxen and ox plough for farming.
  
4. Payment: indicate the payment term (consultancy firm) and (in the case of individual consultant refer to the TOR attached).
  
5. Business Contact details including President/Owners/CEO of the company.
  
6. UNIDOR is not subject to VAT; therefore, all offers should be exclusive of VAT costs.

## **REQUEST FOR PROPOSAL EVALUATION CRITERIA.**

The criteria applied for the evaluation will be

**a. The legal conformity,**

Provide legal required documents of the company as follows;

- Copy of the company's certificate of incorporation,
- Copy of Chamber of Commerce registration,
- Copy Tax Identification Certificate,
- Copy of Certificate of Operation,
- Company's official address,
- Bank account details (where money would be paid),

**b. The price based on the current content:**

The overall value of the consultancy.

**c. The technical experiences:**

Attach copies of reference list of at least three NGOs/NNGOs for conducted training to farmers how to oxen and ox plough for farming.

**d. The compliance with technical specifications and quality standards:**

Provide detailed how the work will be done as stated on the TOR

**e. The work plan timeframe;**

Clearly indicate the workplan it will take to supply the stated items.
