- Ensure provision of medicines based on doctor/clinical officer prescription and advice.
- Ensure provision of inpatient wards services through administration of drugs prescribed by the doctors, providing wound care and dressing.
- Able to insert intravenous cannulas for all age groups and give parenteral antibiotics at the right dose and time.
- Monitor patient vital signs and ensure proper monitoring of the vital signs timely.
- Update patient files and educate patients on the rational use of medicines.
- Consulting and informing the doctor/clinical officer and site manager on issues that may affect the smooth operations of the health facility.

Preparing and updating the inpatient reports and files.
