1. Background to the organisation

BBC Media Action was founded in 1999 as an international development charity. BBC Media Action is registered with Relief and Rehabilitation Commission (RRC) as Non-Governmental Organisation that uses Media for Development (M4D). BBC Media Action uses media and communication to reduce poverty and promote human rights in developing countries. We partner with civil society organisations, local media and governments to: (i) Produce creative programmes based on robust research in multi-media formats which inform and engage audiences around key development issues and (ii) Strengthen the media sector through building professional capacity and equipping the stations.

- Manage the deployment, monitoring, maintenance, development, upgrade, and support of all current IT systems, including LAN, WLAN and wi-fi connectivity, PCs, operating systems, software applications, and peripherals
- Manage total network, core switch, routing and firewall.
- Manage Storage System (SAN or NAS Drives)
- Manage Local conferencing systems (video/audio);
- Ensure server management (including backup, security etc) is done effectively;
- Anti-virus management;
- Inventory and asset management for all IT equipment including licenses;
- Email management



- Data Centre Power Management
- Local Technology Projects e.g. online projects, upgrades etc
- User desktop, laptop, printer, scanner maintenance and troubleshooting.

- User training
- Maintenance of broadcast technology systems (studio, edit facilities)
