#### PURPOSE OF DIVISION:

### JOB PURPOSE:

The WASH Officer will be responsible for providing technical support in the implementation of WASH projects both hardware and software components of WASH program including drilling/rehabilitation of water facilities and generating BOQs, technical drawings/ designs and day to day supervision of field activities to ensure quality service delivery. The duty holder shall remain responsible for all the software components that include but are not limited to; Community mobilization and capacity building training, HESAN awareness activities, and home improvement campaigns using CLTS, PHAST and CHAST hygiene methodologies/ approaches and periodic WASH data collection among others.

- The WASH officer shall be responsible to develop and share all the relevant work plans to aid effective and timely project implementation.
- The WASH Officer will conduct continual review of technical designs and functionality of water supply systems and hand pumps to ensure efficient operation as well as reliability and supply of clean portable water for targeted communities.
- Regularly monitor IDPs and host community's water supplies and estimate water requirement vis-à-vis the production of water from wells and hand pumps within the area.
- The duty holder shall fully participate in the development of BoQ and designs for all WASH
  infrastructural interventions with support from the WASH Engineer on the various projects
  including but not limited to latrines construction, borehole drilling and rehabilitations, etc.
- Work with the WASH team to design templates, construction BoQ for WASH related works, and a develop systems for monitoring work progress of the various project activities and performance of hired contractors.
- Provide rigorous supervision of WASH software and hardware works in the various IRW'S intervention areas.
- Provide technical supervision of contractors undertaking various IRW construction works in the villages/IDPs, host communities, and ensure work is delivered up to standard required by IRW.
- Periodically, conduct water quality testing for the established water facilities to ensure quality water supplies for the community.
- Participate in carrying out communicable diseases' surveillance in the community.
- Review technical reports from the various contractors and provide recommendations to the WASH Coordinator on whether the delivered infrastructures meet required standards and quality.
- Provide technical inputs in the development of IRW regular reports both internally and externally: Weekly, monthly, quarterly, & annual reports.
- Provide technical input/ verification of goods supplied by vendors before distributions.
- Provide capacity building training for WASH technicians, Hygiene promoters, Hand pump mechanics and Water Management committees (WMC) including community and school health committees/clubs to improve quality of service delivery.
- Provide regular field reports/updates to immediate supervisor on the overall WASH interventions in field location
