1. Background

The 2013 crisis in South Sudan, which began in December, had devastating impacts on the infrastructure and vocational education systems in key towns like Malakal and Bentiu. The conflict, originating from a political dispute within the ruling Sudan People's Liberation Movement (SPLM), quickly escalated into widespread violence along ethnic lines. Malakal, the capital of Upper Nile State, experienced severe destruction, with key facilities, including hospitals, schools, and homes, being destroyed or severely damaged disrupting essential services like healthcare and education.

The conflict had a profound impact on the education sector, particularly vocational schools. Many vocational training centers in Malakal were either destroyed or occupied by armed forces, disrupting the education of thousands of students. The violence led to the closure of numerous schools, and many students and teachers were displaced. This disruption had long-term effects on human capital development, significantly reducing school enrolment and the quality of education. The Sudan crisis that started in April 2023 has further exacerbated the situation, leading to a humanitarian emergency characterized by a mass exodus of individuals seeking refuge from the ongoing conflict, recurrent natural disasters, and internal communal conflicts, resulting in widespread displacement and acute vulnerability.

In response to this dire situation, the International Organization for Migration (IOM), with funding from the European Union's International Partnerships (EU-INTPA), has initiated a regional project to provide essential humanitarian support to those affected by the Sudan crisis. This project, jointly implemented by IOM and the United Nations High Commissioner for Refugees (UNHCR), spans across South Sudan, Ethiopia, and Chad, with a particular focus on the most impacted regions in South Sudan: the Upper Nile, Unity State, and Northern Bahr el Ghazal. The project has a component on skill development for returnees, refugees, internally displaced persons (IDPs). An essential part of this project is a transformative skill development program for young people, men, and women through vocational skills training.

The Technical and Vocational Education and Training (TVET) sector plays a crucial role in equipping individuals with the skills and knowledge required to meet the demands of the labour market. Considering the evolving economic landscape and the need for a skilled workforce, it is imperative to develop a comprehensive Vocational School master plan that aligns with national development goals and industry



needs. This consultancy aims to provide technical assistance in the development of a master plan that will guide the revival and future direction of Malakal Vocational school.

2. Purpose of the Consultancy

The purpose of this consultancy is to develop a Vocational School master plan that will serve as a strategic framework for the Revival, enhancement and expansion of Vocational Training programs at Malakal Vocational School. The consultant will work closely with key stakeholders to assess the current state of Malakal Vocational School, identify gaps and opportunities, and formulate actionable recommendations to improve the quality and relevance of Vocational School offerings.

3. Objectives

The main objectives of the consultancy are:

- To conduct a comprehensive assessment of the current Malakal Vocational School landscape, including existing programs, infrastructure, and stakeholder engagement.
- To identify key areas for improvement and development within the Vocational School.
- To develop a strategic master plan that outlines clear goals, objectives, and implementation strategies.
- To provide recommendations for policy and institutional reforms to support the effective implementation of the master plan.
