1.BACKGROUND INFORMATION

The Government of South Sudan, through the Ministry of Water Resources and Irrigation (MWRI), is preparing two projects to address key water sector challenges in South Sudan: (i) the Climate Resilient Flood Management project that is included in the Phase 1 of the Regional Climate Resilience Program (RCRP) for Eastern and Southern Africa, and (ii) Groundwater for Resilience Project (GW4R).

- RCRP: The Phase 1 of the RCRP aims to improve the management of water-related climate impacts in Eastern and Southern Africa with South Sudan as one of the focus countries. This initial project is meant to help South Sudan prepare for the long-term flood and drought protection measures and investments. It focuses on non-structural measures, including climate resilient water resource management planning, early warning, improved monitoring and forecasting capacities, flood risk mapping, and community level interventions, rehabilitation of existing flood protection and water retention and storage infrastructure, including potential support to natural-capital based livelihood activities in flood-prone areas. Total potential project financing for South Sudan RCRP Phase 1 is US\$ 215M for a period of 5 years (2023 2028).
- GW4R: The Horn of Africa (HoA) Groundwater for Resilience Project (GW4R) aims to increase the sustainable access and management of groundwater in the HoA's borderlands through i) investment in groundwater infrastructure and inclusive community use; ii) development of groundwater institution and information; and iii) technical assistance for project management, knowledge, and operations. The South Sudan part is meant to

address development, access, and management of South Sudan's rich and relatively untapped groundwater aquifers such as Sudd and Baggara. Unlocking the groundwater resources has potential to improve the livelihood and enhance the resilience to climate change impact in the borderlands and adjacent marginalized areas of the country. South Sudan through MWRI expressed is joining the second phase of the regional HoA GW4R Project with project financing up to US\$ 40 million for a period of 6 years (2024 -2030).

Both projects will be led by the government, through the MWRI, and financed by the World Bank through grants from the International Development Association (IDA). Particularly for the case of the RCRP, IDA financing comes from the national allocation to South Sudan and several other windows: i) regional integration (RI), ii) crisis response windows (CRW), and iii) the window for Host Communities and Refugees (HRW). The MWRI has established a Project implementation Unit (PIU) to manage the preparation and implementation of the projects where technical assistance under the project management component is needed to leverage opportunities for capacity building and to support aspects such as compliance with Environmental and Social Standards (ESS) and the Environmental and Social Management Framework (ESMF), fiduciary capacity building, M&E, third-party monitoring (TPM), etc.

A Project preparation Advance (PPA) has been approved for the RCRP Phase 1 – South Sudan and the MWRI intends to apply part of the PPA proceeds towards recruitment of experts who will work alongside with the National staff drawn from the Ministry of Water resources and Irrigation to support the PIU smooth implementation of the RCRP project. Some of the identified specialists will provide support to both the RCRP and the HoA GW4D projects.

A Project Implementation Unit (PIU) shall be established within the MWRI for RCRP with the primary task of project implementation and overseeing service providers, stakeholder outreach and communications, fiduciary and procurement management, Monitoring and Evaluation (M&E), community engagement, and risk management related to social and environmental safeguards, fiduciary oversight as well as maintaining infrastructure quality and standards.

The Ministry of Water Resources and Irrigation intends to apply part of the proceeds of the grant to fund the position of a Senior Social Development Specialist to ensure that all activities. particularly civil works and other related activities under both Projects are undertaken in full compliance with the Projects' Environmental and Social Management Framework (ESMF) and World Bank Environmental and Social Standards (ESS) freely available for consultation at: https://www.worldbank.org/en/projects-operations/environmental-and-social-

He/she will be based in the Project Implementation Unit.

2. Scope of Services and Responsibilities: The scope of services for the position includes but not limited to the following duties and responsibilities:

Of LaEpsure that all activities, civil works related activities, under the two projects particularly the RCRP including the PPA, are undertaken in full compliance with the Project's Environmental and Social Management Framework (ESMF).

- Provide overall social management oversight during the implementation of the project, support and advise the Project Manager and the project team in addressing social issues at all the stages of the implementation.
- Provide guidance and technical support for screening activities under both projects for social risks and impacts and vulnerabilities, identify impact and risk management opportunities/strategies, and prepare the required E&S instruments (ESIA/ESMP/RAPs).
- Lead on the implementation of stakeholder engagement activities as per the Projects' Stakeholder Engagement Plans (SEPs), including the implementation of information dissemination and stakeholder consultations.
- Contribute to the preparation of the project implementation manual (PIM) with focus on social standards and social risk management aspects.
- Lead on the implementation and administration of the Projects' Grievance Redress Mechanisms (GRM).
- Support the implementation of the Projects' Sexual Exploitation and Abuse (SEA) / Sexual Harassment (SH) Action Plans.
- Ensure compliance of all Project workers with the Projects' Labor Management Procedures (LMP).
- Guide the project implementing partners /works contractors in preparing the necessary E&S instruments (ESIA/ESMP/RAP) and review them for quality assurance.
- Maintain regular dialogue and assist with enhancing implementing partners /works contractors' capacity to comply with World Bank environmental and social standards.
- Monitor compliance of project-financed activities with World Bank social standards and mitigation measures as laid out in the Projects' E&S instruments by participating in project technical discussions and field visits, reviewing project reports and recommending adequate measures.
- Assist the PIU in liaising with the World Bank social specialists.
- Administer the reception and review of implementing partners' and contractors' regular reports, including the preparation of reporting templates.
- Prepare E&S compliance inputs on social issues, the SEP, the GRM, the SEA/SH Action Plan, and other topics as part of the regular Project Progress Reports to the World Bank.
- **3. Selection Criteria**: Selection shall be based on qualification and experience of the candidate and followed by an interview. The qualification and experience required for short listing will include:
- (i) University degree (MA or PhD) in social sciences, including Sociology, Social Anthropology, Development Studies or similar subjects is required; (ii) minimum of 8 years of full-time relevant professional experience in social development and social risks management; (iii) Exposure to the development work with international organizations and a range of stakeholders is an advantage; (iv) experience in stakeholder engagement required; (v) demonstrated experience conducting social assessment and management of social risks and impacts in a development/humanitarian organization, Government agency and/or private firm in FCV Countries; (vi) good interpersonal and communication skills; (vii) demonstrated ability to work in a team; (viii) fluency in English is

required (writing, speaking, listening and reading); and (ix) computer literacy (MS Office) and good quantitative analytical skills.

The shortlisted candidates will be invited for oral interview. Consultant will be required to possess the skills, concepts, knowledge, and principles required to carry out the job tasks.

Government officials or civil servants will not be considered unless: (i) they are on leave of absence without pay or have resigned or retired six months prior to the date of the advert; and (ii) their employment will not create Conflict of interest.

- **4. Duration:** Duration of the assignment is 24 months. The consultant will undergo 3 Months' probation period before issuance of a One (1) year contract that is subject to renewal based of satisfactory performance.
