Purpose of the position:

The County Coordinator will be responsible for the quality and sound implementation of the HPF3 project in Tambura County. She/ he will ensure that all project deliverables are achieved and reports are shared in time with the HPF3 Project Manager. The incumbent will directly supervise all operations of HPF in activities in Tambura area. She/ he will ensure that WVSS child protection policy is adhered to at all times.

The County Coordinator is expected to have strong leadership qualities and depth and breadth of technical expertise, and project management, monitoring and evaluation, and budget management expertise. The County Coordinator shall have a keen understanding of the unique political and socio- cultural context of S/Sudan Major Roles and Responsibilities:

## **Project Implementation:**

- Provide leadership in the implementation of Primary Health Care services in Tambura County as guide by the project objectives, logical framework and work plan.
- Improve Maternal and Child Health indicators and EPI coverage.
- In liaison with CHD conduct weekly, monthly and quarterly supervisory visits to the Health facilities.
- Carry out additional responsibilities and projects as assigned, including administrative and planning functions.

Strategic leadership and Representation:

- Manage proactive and responsive relationship with county authorities in close collaboration with the Project Manager, Hospital Coordinator.
- · Directly oversee project implementation, ensuring that all strategic objectives are met through proper design, staffing, implementation and quality assurance at county level.
  - Support CHD staff and build capacity of health workers to manage health activities.
  - Respond to adhoc project and donor requests

Qualifications: Education/Knowledge/Technical Skills and Experience

- Flexibility, ability to multitask, ability to handle pressure well and meet deadlines, ability to improvise
- Excellent analytical/problem-solving skills and detail-orientation
- Experience in Project Manager is required.
- Experience and knowledge in managing maternal and child health program
- Experience in emergency preparedness and response preferably in communicable disease such as Measles, Ebola, Cholera, and Hep E etc.
- Professional experience in emergency response
