
A LOCAL SECURITY FIRM has this 28th day of **October 2019** been vetted by Internal Security Bureau (ISB) under **Chapter 3, Article 13 (1)** of the National Security Service (NSS) **Act 2014** and has been given a Security Clearance to operate as **A LOCAL SECURITY FIRM** in the Republic of South Sudan.

This permit is subject to the following conditions/directions: -

1. The Organization shall carry out its activities in the fields of private security sector that will includes the provision of mobile and key point protective security services (guarding and incident response services).
2. Uniforms and equipment should not be Para-military in appearance and must be clearly distinguishable from uniforms and equipment used by Security Organs of the Republic of South Sudan.
3. Use of National flag badge in private security uniform is prohibited.
4. Will not associate with international military procurement and supply what so ever.
5. The content of the initial training given to their recruits and continued training programmes for their employees MUST be approved by Internal Security Bureau
6. Employees' contracts MUST be compliant with relevant regulations of the Republic of South Sudan and all International or regional staffs must have their backgrounds checked by Internal Security Bureau prior to offering of job by the company, and must acquire residence and relevant work permits.

7. Use of firearms and other lethal weapons is not authorized.
8. Use of armored vehicles is not authorized unless approved by Internal Security Bureau for specific contracts and purposes on full justification on a case-by-case basis in addition to the requirement for an Operations Clearance Certificate.

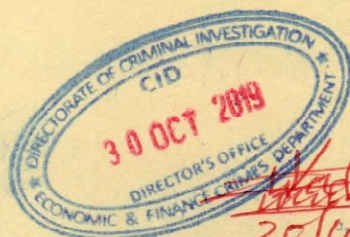
