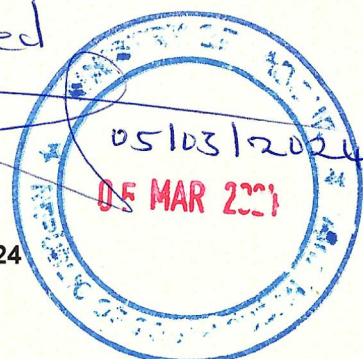

Introduction

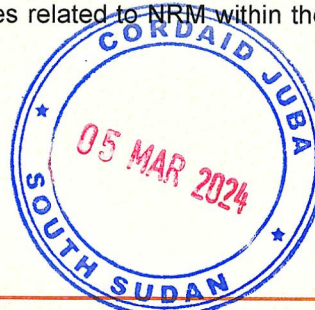

Purpose of the position

The NRM Nutrition and Livelihoods Project Coordinator position will provide technical support in the implementation of Natural Resources Management, Disaster Risk Reduction, Nutrition, and Alternative livelihoods initiatives in Yambio and Nzara Counties of Western Equatoria State. The NRM, Nutrition, and Livelihoods Coordinator will advise on how to integrate DRR intervention across the key thematic areas of NRM and Nutrition and Livelihood. He/she will implement initiatives related to NRM within the delineated areas of YUBU, in close collaboration with GIZ the front Donor.



Key accountabilities and Responsibilities

- Coordinate and follow up on nutrition program implementation to review progress towards objectives through organizing regular review meetings, updates, and experience-sharing meetings among staff.
- In collaboration with the project team, identify existing project implementation gaps and new opportunities for nutrition and nutrition-related projects.
- Lead, plan, and conduct nutritional initiatives implementation, monitoring, mentoring, and provision of support to the technical.
- Technical Support/Capacity Building; building capacity of NRM Assistants and catchment and sub-catchment committees through training, mentoring, and supervision.
- Coordination with partners implementing similar interventions, GIZ field office staff, state/County and Payam government representatives.
- Actively participate and represent Cordaid in nutrition, food security, and Livelihood sectors coordination forums, discussions, and activities, serve as Cordaid's resource person, and display technical and organizational leadership in sectoral activities.
- Create and maintain smooth relations and open collaboration with Government and local stakeholders.
- Perform other related duties as may be assigned by the supervisor.

Qualifications and skills

- BSc Honors degree in an appropriate field related to Natural Resource Management, Disaster Risk Management, Rural Development, Nutrition, or other related areas such as (conservation, environmental science, natural resources management, and freshwater ecology).
- At least 3 years of experience developing and implementing projects in one or more of the above-mentioned fields.
- Experience with multi-disciplinary environment teams, (Government, NGOs, Civil Society), would be a strong asset.
- Knowledge of the institutional and legal framework of the environment and conservation in South Sudan, as well as of relevant policy issues.
- Experience working with the government and with donors/government aid agencies and civil society in South Sudan.
- Excellent English communication skills (oral and written) and local Arabic language.
- Excellent interpersonal skills, including the ability to develop and maintain strong relationships at all levels, including with local communities, government agencies, and other partner organizations.
- Experience in the facilitation of training and workshops.
- Experience in budget management, logistics, and Human Resources Management.
- Experience in writing/developing project proposals and project reports.
