The Government of the Republic of South Sudan (GRSS) has received a grant from the International Development Association (IDA) to implement the Regional Climate Resilience Program (RCRP) under phase 1. The GRSS intends to utilize part of the proceeds of this financing to recruit a competent expert for the position of GIS Specialist with duty station at the Ministry of Water Resources and Irrigation's Project Implementation Unit (PIU) Office, based in Hai El Cinema in Juba, South Sudan.

2. The consulting services ("the Services") main objective is to enhance the capacity of MWRI in designing, developing, and implement systems and databases to access and store geospatial data, analyse data utilizing mapping software, design digital maps using geospatial data and analyse spatial and non-spatial information for the Ministry of Water Resources and Irrigation.

3. The assignment shall be for a period of one year renewable subject to a mandatory probation period of three months of satisfactory performance.

The shortlisting criteria are:



- i. Minimum of a Bachelor's degree in GIS, Geography, Remote sensing or related field with demonstrated capabilities in GIS, a Master's Degree in GIS, Environment, Climate or any other related field will be an added advantage.
 - ii. Minimum of 5 years of ESRI ArcGIS experience, QGIS -related application in Engineering or related field.
 - iii. Previous experience in developing GIS and remote sensing deliverable,
 - iv. Proficiency using ESRI ArcGIS Software, QGIS Software, and Microsoft Office is desired.
