TERMS OF REFERENCE FOR CONSULTANCY SERVICES

DEVELOPMENT OF A TRAINING MANUAL FOR SCHOOL-RELATED GENDER-BASED VIOLENCE (SRGBV)

1. Background:

The 2023-2026 Education Cannot Wait (ECW)-Multi Year Resilience Programme Phase 2 (MYRP 2) for South Sudan builds on the successes and lessons learned from the 2019 MYRP. Led by Save the Children International (SCI) and the additional grantees of the Norwegian Refugee Council (NRC) and Finn Church Aid (FCA), along with technical and implementing partners, the project is implemented by 14 partners in six States of South Sudan. These include Eastern Equatoria, Unity, Jongolei, Warrap, Upper Nile, Lakes and Pibor and Abyei Administrative Areas of South Sudan. The project was designed as a gender transformative programme, going beyond responding to the gender barriers and working to address the underlying causes of those concerns.

The MYRP 2 partners leverage their complementary strengths to implement a holistic programme across **five outcomes** with the aim of reaching 135,000 of the most in-need girls and boys across the prioritized counties.

Outcome 1: Safe, equitable, gender responsive, and uninterrupted access to protective and quality learning opportunities increased for crisis-affected girls and boys including those with disabilities.

Outcome 2: The quality of teaching and learning is improved in crisis-affected communities through inclusive and gender transformative approaches.

Outcome 3: Education becomes more inclusive through comprehensive, gender transformative and disability inclusive strategies.

Outcome 4: The education system becomes more responsive and resilient to the impacts of crisis through improved data for decision-making, strengthened coordination, and meaningful engagement of local actors.

Outcome 5: Sufficient resources are mobilized to scale the implementation of the multi-year programme, respond to cyclical and new crises, build sector capacities, and monitor programme quality.

The consortium works together to ensure safe and equitable access, improved quality of teaching and learning, increased inclusivity, and a more resilient education system in collaboration with Ministry of General Education and Instruction (MOGEI), the Education 5000AN

Cluster, and other flagship education programmes in the country. The MYRP2 seeks to reach the most in-need learners and improve the overall capacity to reach more in the years to come. The programme also works to engage, enrol, and support the education of those girls and boys with disabilities.

The result is a programme that seeks to expand access to education for girls, to ensure their retention in learning, and to directly confront the social norms and stigmas that threaten their education. This strategy cuts across all the MYRP's outcomes, with gender specific outputs for the access, quality, equity and systems supports and with Plan International as the GLO to help guide their implementation.

Plan International (PI) strives to advance children's rights and equality for girls all over the world. As an independent development and humanitarian organisation, we work alongside children, young people, our supporters, and partners to tackle the root causes of the challenges facing girls and all vulnerable children. For over 80 years, Plan International has build powerful partnerships for children, and is active in over 80 countries. Plan International is committed to promoting gender equality and inclusive education as essential components of sustainable development. However, challenges persist in achieving these goals, including cultural norms, socioeconomic disparities, and inadequate access to quality education.

2. Overview of School-Related Gender-Based Violence (SRGBV) in South Sudan:

South Sudan, the world's youngest nation, has faced significant challenges since gaining independence in 2011. Persistent conflict, political instability, economic hardships, and underdeveloped infrastructure have contributed to a complex environment for education. These factors can exacerbate vulnerabilities and contribute to instances of School-Related Gender-Based Violence (SRGBV). SRGBV in South Sudan is a concern that affects both girls and boys. Incidents of violence, harassment, and discrimination occur within educational institutions, deterring children from attending school and hindering their ability to learn in a safe and supportive environment.

3. Consultancy Objectives:

The primary objective of this consultancy are as follows:

To develop a comprehensive training manual addressing School-Related Gender-Based Violence (SRGBV) for use in educational institutions in South Sudan. The manual should be designed to empower educators, administrators, and relevant stakeholders with the knowledge and skills necessary to prevent, recognize, and respond to SRGBV.

4. Scope of Work:

The consultant is expected to:

- a) Conduct a thorough review of existing literature, guidelines, and best practices related to SRGBV in educational settings.
- b) Collaborate with stakeholders, including educators, students/learners, parents, and relevant authorities, to understand local context and challenges.





- c) Develop a set of training modules covering key topics such as identification of SRGBV, prevention strategies, reporting mechanisms, and support systems.
- d) Create engaging and interactive training materials, including presentations that include powerpoints, case studies, role-playing scenarios, messages for awareness for IEC materials and assessment tools.
- e) Ensure that the training manuals are gender-sensitive, culturally relevant, and applicable to diverse educational settings.
- f) Prepare and share the training modules including Power Point Presentations and materials for key stakeholders in a one-day session to check acceptability/validation workshop.
- g) Present the revised document with feedback incorporated
- h) Documentation of the training session conducted and share report.

5. Deliverables:

The consultant is expected to deliver the following:

- a) An Inception Report outlining the approach, methodology, and work plan.
- b) Draft version of the training manual for review and feedback.
- c) Final versions of the training manual and power point version incorporating feedback from stakeholders.
- d) Electronic copies of all materials in editable formats.

6. Duration:

The consultancy is to be completed within 30 days from the date of contract signing. The consultant should provide a detailed timeline in the inception report, indicating key milestones and deadlines.

7. Qualifications and Experience:

The selected consultant should have:

- a. A proven record of accomplishment in developing training materials, particularly in the field of gender-based violence, Child protection, gender or education.
- b. Knowledge of South Sudan's education system, laws, and policies.
- c. Knowledge of international and regional, guidelines, standards and frameworks and guidelines on GBV, Child protection, education
- d. Expertise in gender issues and a deep understanding of SRGBV.
- e. Experience working in diverse cultural and educational settings.
- f. Experience in conducting training and capacity building for diverse stakeholders.
- g. Strong communication and collaboration skills
- h. Strong research and report-writing skills

- The consultancy team/ a consultant with a gender and education expert, Child Protection, policy and advocacy, human rights, Monitoring, Evaluation and Research expert will be prioritized.
- The team or at least the team leader should possess advanced university degree (Master's degree or equivalent) in Education Studies, Social Sciences, Development Studies, Public Policy, Gender Studies, Human Rights or related discipline.

8. Safeguarding Children and Program Participant Policy

Plan International is committed to actively safeguarding children and program participants from harm and ensuring children's rights to protection are fully realized. Plan takes seriously the commitment to promote child-safe practices and protection from harm, abuse, neglect and any form of exploitation as they come into contact with Plan International-supported interventions. In addition, we will take positive action to prevent child abusers from becoming involved with Plan International in any way and take stringent measures against any Plan International Staff and/or Associate who abuses a child or program participant. Decisions and actions in response to safeguarding concerns will be guided by the principle of 'the best interests of the child.'

Consultants are required to provide a statement within their proposal on how they will adhere to the above-mentioned policies, including how they will ensure ethics and protection of adolescents in the different stages of the reviews — including data collection and analysis, visits and report writing. This is in line with Plan International's Gender Equality and Inclusion Policy and Safeguarding children and program participant Policy. This must also consider any risks related to the study and how these will be mitigated. Consideration must be given to:

- Safeguards to protect the confidentiality of those participating in the study.
- Data protection and secure maintenance procedures for personal information Plan International will provide orientation on gender equality, inclusion, child protection and safeguarding issues for consultancy team

9. Proposal Submission:

Interested consultants or consulting firms should submit a detailed proposal that includes the following:

- Technical proposal outlining the approach to be used for the consultancy.
- 2. Financial proposal with a breakdown of costs including costs for expert consultations, stakeholder engagement, data collection-desk reviews, analysis, and report/document writing.
- 3. Curriculum vitae of key team members.
- 4. Portfolio of previous relevant work (samples of approved reports and certificates) related to education sector, gender-based violence, child protection, human rights, girls empowerment.
