General job description:

Under the supervision of the Program Manager, the FSL Specialist is responsible for the daily technical planning, implementation, supervision, monitoring, and reporting of the Food Security and Livelihood (FSL) field activities. He/she shall ensure proper coordination with relevant stakeholders including; the FSL cluster, authorities (both the local community and local government), humanitarian actors, and beneficiaries.

Expected outputs: Tasks and Responsibilities

Output 1: Ensure timely and quality implementation of FSL activities.

 Design a fair and justifiable beneficiary selection criterion together with the line ministry at State/County/Payam/village level.

 Design and plan for timely implementation of FSL activities. These include induction sessions, tool, and seed bank establishment, formation of farmer groups, conducting modern agricultural training, set up of farms, training of farmer groups in Village Saving and Loans Association (VSLA), monitoring, and reporting.

Work closely with the Programme Manager creating monthly work plans, and budgets.

Output 2: Ensure Coordination with all Stakeholders

- The FSL Specialist shall ensure all FSL Programs/projects and activities contribute to and are well coordinated with National and sub-national strategies/objectives set by the cluster.
- The FSL expert shall ensure that LM International South Sudan is an active member of FSL Cluster through the annual submission of HRP, monthly 5W reports to the cluster, and active participation in meetings and forums.
- The FSL expert shall ensure proper coordination with relevant stakeholders including; FSL cluster, authorities (both the local community, Local government, and state line ministry), other humanitarian actors, and beneficiaries to avoid duplication of project activities.

Output 3: Project Performance Management, Data Collection, and Reporting.

- Develop Monitoring and Evaluation tools/templates to track the progress of FSL project activities.
- Collect, analyze, and report agricultural farm data and household data from beneficiaries through, observations, measurements, focus group discussions, questionnaires, and key informant interviews.
- Document stories of success that capture the relevance and impact of the FSL projects.
- Compile and submit monthly/quarterly/annual required reports with good-quality photographs according to the schedules established.
- Capture and document challenges faced, the proposed way forward, and lessons learned.
- Ensure a functioning Feedback and Complaint Response Mechanism accessible to all stakeholders

Output 4: Increasing FSL Projects/Donor base

The FSL Specialist shall write solicited and unsolicited proposals to various funding bodies.


