BACKGROUND

Under direct supervision of Agricultural Extension Supervisor, the Agricultural Extension field Officer will ensure that the project objective of increasing agriculture production at the household level is achieved through planning and coordinating community mobilization, facilitating distribution of livelihood inputs and offering agriculture extension services to farmers

KEY RESPONSIBILITIES:

- 1. Key result #1: Community mobilization and beneficiary selection and targeting (15%)
- Mobilize and sensitize the community on the FH mandate and the project.
- Using the community based targeting approach, identify beneficiary households that meet the targeting criteria
- 2. Key Results # 2: Livelihood input distribution and farmers training (80%)
- Organize identified beneficiary households to receive livelihood inputs and assist with logistical planning and coordination of the distribution.
- Organize farmers into training groups guided by the project document.
- Train Farmers in improved agronomic practices mainstreaming COVID 19 risk mitigation strategies in the training.
- Facilitate the establishment of demonstration gardens by Lead Farmers.
- Produce a report after every training session conducted using the provided reporting template.
- Continuously provide technical support to farmers throughout the growing season.
- 3. Key Results #2. Security Responsibilities (5%)
- Report any security incident to the Agriculture supervisor within 24 hours.
- Adhere to safety and security protocols always during project implementation.
- Ensure safety and security of FH assets always during field operations.
