1.0 Project Overview

The Youth for Works project aims to strengthen employment skills, economic livelihood and market development opportunities among the youths in acute food insecurity in Kajokeji County-Central Equatoria State.

The project will cover two (2) work streams:

1. Education and skill-building – This will be delivered online courses and face-to-face training and will cover technical /vocational areas, agronomic practices, computer literacy, entrepreneurship, and business management skills.
2. Support for Small-business Startup – The project will provide equipment, capital and start-up kits for various small businesses to enable the trained youth earn a livelihood..

The Project seeks sustained improvement in the quality of life of the rural youths and women by strengthening low-income rural markets, stimulating local economic development and diversifying employment and livelihood opportunities, which can also contribute towards the national development goals of inclusive economic growth, and poverty alleviation through the establishment of an E-Learning model center, short course TVET.

2.0 Objective

An effective curriculum provides teachers, students, school leaders and community stakeholders with a measurable plan and structure for delivering a quality education. The curriculum for Technical Vocational Education Training (TVET) will identify the learning outcomes, standards and core competencies that students must demonstrate before receiving their qualifications. It is therefore necessary to develop a curriculum that will be both theoretical for students to understand concepts and practical to enable them to practice and actualize what they have learnt.

The curriculum will serve as a guide and learning tool for the students in the following subjects within the stipulated time period:

1. Computer learning (Use of email, Microsoft office, Search Engines) at the E-Learning center for 2 weeks
2. Mobile Phone Repair for 1 month
3. Motorbike Repair for 3 months
4. Brick making for 3 months
5. Masonry for 3 months

The developed curriculum will be developed in English, which is also the language for instruction. The students will also be provided with their copies for future reference.
