AIM OF THE POSITION

- Veterinarian 2 plans, implements and monitors the Economic Security (EcoSec) Unit's livestock programmes in line with the country strategy and under the supervision and guidance of their hierarchical superior.

Main Duties and Responsibilities:

- Carries out health briefings for all new ICRC staff.
- Assists the Veterinary Surgeon and work closely with the EcoSec Delegate (s) based in Bor in the designing, planning, implementation and monitoring of livestock programs in Jonglei State in cooperation with local communities and authorities such Ministry of Livestock Industry and Forestry (MLIF).
- Works in close collaboration with the Livestock project and Economic Security Generalists and other Veterinarian in BRX Area of Responsibilities.
- Ensures that mutual understanding of rights and responsibilities on the side of ICRC and external partners Ministry of Livestock Industry and Forestry (MLIF).
- Prepares or organizes delivery of Community Animal Health Workers training courses as well as the treatment and vaccination campaigns.
- Actively participates in household assessment and focus group discussions with the livestock owners and prepares the questionnaires for data entry.
- Independently performs the data entry and the analysis of the household assessment.
- Provides regular and consistent reporting on the activities carried out in the field as well as the appropriate internal technical reporting.
- Supports the Economic Security Department to develop a deep understanding of the dynamics of the livestock sector in Jonglei State, including government intervention and private trade.
- Translates whenever there is a need during interlocutors and beneficiaries in the field.
- Follows up all the logistics and administration procedures related to the implementation of livestock programs.
- Assists the Economic Security Delegates on any other requested duty and acts as a generalist (i.e. assists to implement relief and agro Economic Security programs) if needed.
- Ensures that all Field Trip Reports are submitted to the hierarchy in a timely fashion.
- Follow-ups and updates relevant files and databases for the unit.
- Coordinates activities and response with other primary and secondary stakeholders, attends and

represents the ICRC at relevant external coordination meetings as advised by the veterinary surgeon and EcoSec Delegate (s).

- Maintains a close link with the EcoSec and Livestock Delegates in the field for any question related to livestock programs, procedures and distribution figures;
- Internally, interacts with ICRC staff at the Sub-Delegation level and at the Delegation level when needed.
- Externally, maintains and develops a network of contacts (members of the population, community leaders, local authorities, NGOs, etc.) upon request from the direct supervisor to support and facilitate the EcoSec activities.

Minimum required knowledge & experience:

- Specialized veterinary degree (2–3 years) or university degree in veterinary medicine or veterinary surgery.
- Minimum four years' experience working with livestock at an NGO or international organization.
- Good command (spoken and written) of English and/or Arabic.
- Expert level in computer skills.
- Proven ability to manage activities involving livestock.
- Extensive knowledge of the livestock sector of South Sudan as well as of the most prevalent animal diseases, animal treatment and vaccination, main migration routes and its importance to water and pasture.
- Skilled in the following competencies; Networking & Communication; adapting & learning; Responsibility & Autonomy; Communication (ability to express views and ideas).
- Good knowledge of ICRC mandate, IHL, and of other humanitarian topics;
- Good knowledge of local languages and geographically assigned environment.
- Solvent experience in reporting and writing of project proposals.
- Work experience from an NGOs, INGOs will be an asset.
- Flexibility and willingness to stay in the field 70-75% of his/her working time.
