#### **BACKGROUND/INTRODUCTION**

Islamic Relief is an independent humanitarian and development UK based organization, with an active presence in over 40 Countries across the globe, we strive to make the world a better and fairer place for people still living in poverty. Islamic relief began its humanitarian operation in South Sudan in 2004 focusing on providing lifesaving aid and implementing developmental Programmes to support people affected by flood, drought and Conflict establishing three sub offices in Narus (Kapoeta East), Wau, Warrap. A satellite office in Yei and Main office in Juba.

#### INTRODUCTION

With funding from IR USA, IRSS is currently implementing project "Early Recovery and Resilience Program for Communities affected by conflict in South Sudan (ERRP)".

In order to realize this, Islamic relief intends to procure 3000 chickens (2000 Pullets and 1000 Cockerels) and 10 bags of preliminary feeds to stabilize the chicken on arrival under the management of vendors before distribution to the beneficiaries within specified number of days in the contract.

The Overall Goal: The objective of this project is to strengthen poor households' livelihoods and resilience in Wau and Kapoeta East County.

#### 2.0 Terms of Reference:

- **Breed:** Kuroiler (dual-purpose hybrid breed) are preferred because of their hardiness and their tolerance to all climate (hot or cool). F1 Breeds is preferred.
- **Health:** The chick should be healthy, i.e. actively eating, with good vision, hearing and breathing and free from pest and diseases. There should be no major physical injuries and no limping.
- Age: Pullets and Cockerels of 2 3 Months (8 weeks 12 weeks) finisher age are preferred because of their ability to cope up with changing environment furthermore the bird should be at age of uniformity. For example, do not mix Cock/Rooster with cockerel, pullet with hen/layers.
- **Temperament:** Feeds continuously, friendly and scavenge well.
- **Types of feeds:** 10 bags of preliminary feeds to stabilize the chicken on arrival before distribution to the beneficiaries.
- **Batch**; chicken have to be dispatch based on the arrangement with the field focal person (kapoeta/Wau) with clear specification on sexing if they are to be delivered in batches when agreed upon.
- Mandatory; The County Veterinarian shall certify and issue a bill of health for the Chickens purchased/ supplied before delivery and receiving which IRWSS field technical staff will verify. Vaccination: All the chicken has to be vaccinated on Marek, Gumboro, Newcastle, Fowl Pox, Fowl Typhoid before the supply and possibly evidence for the vaccination have to be availed.
- The supplier will procure and distribute the above agricultural inputs to the beneficiaries designated locations or distribution points with as follows:

In Wau, western Bar el Ghazel state, the two Payam where Islamic relief South Sudan is carrying the FSL intervention activities include Bazia and Baggari Payam. In Bazia, Payam, the transportation of chicken will reach to four Boma (villages) Gattan, Taban, Gedi, and Akuyo, with the furthest distance being around 50 to 60 kilometer, in Baggari Payam, Baggari and Biringi around 15-20 Km all from Wau County head equators.

While in Kapoeta East, Eastern Equatoria state, the FSL intervention is carried out in Narus payam with transportation around 15-17km from Narus center to Lopua for distribution
