**INTRODUCTION:**

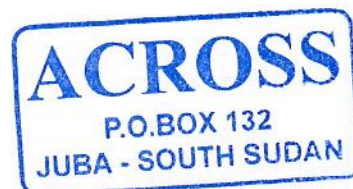

- Master's degree in Project Planning and Management is an added advantage.

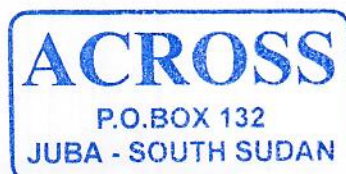
**b. Work Experience**

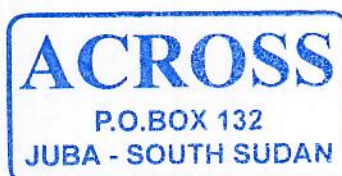
