JOB PURPOSE

In this role, the Project Coordinator will be responsible for the effective implementation, coordination, monitoring, and reporting of the LIFE-ARC project in Aweil East, Northern Bahr el Ghazal (NBEG) State. The LIFE-ARC project focuses on delivering life-saving food assistance to flood-affected, returnees, IDPs and food-insecure communities. The role also involves coordinating with local stakeholders, government agencies, and humanitarian actors to enhance the project's impact and sustainability.

Key Result Areas

Project Implementation and Coordination:

- Oversee and coordinate the day-to-day implementation of all LIFE-ARC project activities which mainly focuses on life-saving food assistance.
- Develop and update detailed project work plans and ensure activities are implemented according to timelines and objectives.
- Supervise project staff, including field officers, community mobilizers, and ensure effective task delegation and team coordination.

2. Monitoring, Evaluation, Accountability, and Learning (MEAL):

- Work closely with the MEAL team to ensure continuous monitoring and evaluation of project activities.
