Introduction

Cordaid is a Dutch, international non-governmental organization which combines 100 years of experience and expertise in emergency aid and structural poverty eradication. Presently, Cordaid is expanding its program in different parts of the country. For that purpose, additional capacity is required. Therefore, Cordaid South Sudan would like to recruit for the position of **TB/HIV Service Program Officer as detailed below.**

Reporting Line:

The TB/HIV Service Program Officer reports to the TB/HIV Specialist.

Purpose of the position:

The position holder will provide technical support to the State and County health department (CHD) and will support County-led programming activities for a decentralized HIV/AIDS and TB response.



Duties and Responsibilities

- Serve as the principal liaison between the SMOH and Project Management by regularly engaging them and representing Cordaid in all relevant forums.
- Provide mentorship and coaching to health facility teams to provide the full spectrum TB/HIV services in line with MoH consolidated guidelines.
- Support community and facility demand for TB/HIV services.
- Work with the relevant SMOH and CHD personnel to ensure provision of an integrated information and service package for improving care for HIV positive pregnant and breastfeeding mothers.
- In collaboration with SMOH and other relevant partners, build the capacity of local partners, county health managers and health care workers to implement continuous quality improvement (CQI) for TB/HIV services.
- Support the effective dissemination of National HIV, TB, and other relevant guidelines within the State.
- Ensure quality project monitoring through timely, accurate and complete reporting in line with the ministry and donor requirement and the use of this monitoring data for decision making.
- Coordinate and adopt best practices from HSS activities to further strengthen and expand interventions to achieve project goals.
- Actively participate in internal and external project review meetings and reporting.
- Identify barriers to program implementation in the State and County-led programming and propose corrective actions.
- Provide call/distance TA support for the handling of complicated HIV/AIDS/TB cases.
- Provide team lead roles for the field office technical supervisory teams.
- Assess compliance of the partner states, counties and sub-recipients to the terms and conditions of the partnerships.
- Any other duties may be reasonably assigned from time to time.

Key qualification and competencies

- 3 years' experience in TB/ HIV program implementation.
- In-depth knowledge in the science and clinical management of HIV.
- Experience in strategic planning, health systems strengthening and participatory approaches.
- Experience in providing technical assistance to large scale HIV HSS interventions within MOH structures and systems.
- Experience in reporting data using the DHIS2 and other relevant software, analysis and use for decision making.
- Familiarity with the functioning of the decentralized Local Government System in South Sudan and the working of local government sub granting.
- Knowledge of Global Fund/UNDP programming policies and regulations, procedures, and practices, which bear on project management in support of cooperative agreements.
- Comprehensive knowledge and experience in TB/HIV management.
- Excellent communication & interpersonal skills plus the ability to work effectively in a team, SMOH, and CHD.
