- 1. To save lives and alleviate suffering among displaced people and their hosts
- 2. To reduce displacement related risks and support and facilitate solutions
- 3. To promote peaceful, inclusive and resilient societies and address root causes to displacement

DRC primarily operates across Upper Nile and Unity states and other parts of the country, both of which are heavily affected by conflict and experience high numbers of internally displaced populations as well as refugees in need of humanitarian assistance. DRC has operational bases in Maban, Malakal, Kodok and Aburoc in Upper Nile, in Bentiu, Mayom, Kodok, Central Equatoria (Magwi and Ngulere), Ajuong Thok in Unity state, and the Mobile Response Team and all are supported by a country-office in Juba.

DRC recently developed important multi-sectorial mobile response teams based in Juba able to rapidly respond to new and urgent humanitarian situations countrywide at short notice to

# Overall purpose of the role:

The purpose of the Economic Recovery Officer is to facilitate the implementation of South Sudan USAID Youth Empowerment Activity programming through partners and coordination with stakeholders in operational areas. The incumbent will support in enhancing the livelihoods of beneficiaries through partner support to ensure the provision of project information, business skills trainings, business support, Cash and Voucher Assistance and agricultural interventions utilizing market systems approaches. The Economic Recovery Officer directly reports to the Economic Recovery Manager (USAID YEA) but also works closely with Economic Recovery Specialist for technical support. The USAID YEA will be implemented through partners thus this role requires the officer to engage with partner with support from line manager.

### Responsibilities:

To achieve the objectives of the position, the Economic Recovery Officer will perform the following tasks and undertake the following responsibilities through USAID YEA Anchor Organizations and Youth Led Service Organizations (indirect implementation);

# General Programming & Operations

Lead community engagement through community mobilization, beneficiary identification and selection processes

To participate in the design and implementation of economic recovery related surveys and assessments in the project areas

 Lead partners in facilitating the implementation of cash transfer programmes in project operational areas. Support the set up, management and supervision of Business Grants, Electronic Vouchers for agricultural inputs, Conditional Cash Transfers and facilitate Cash distributions

- Liaise with M&E to conduct post-distribution monitoring to ensure that beneficiary
  entitlements have been adequately accounted for and reconcile the results with those
  issued by the financial Service Provider and line manager for the supply of cash and
  vouchers.
- Oversee warehousing through coordinating with Logistics in sub office, at distribution sites ensuring that all commodities/cash/inputs/goods arriving at any given point are properly accounted for with systems in place
- Conduct small business management trainings and support beneficiaries in business plan development through partner support
- Work with partners to facilitate the set up and implementation of agricultural activities on the livelihoods programme through liaising with relevant stakeholders
- Contribute to programme design, planning and partner implementation through working with line manager
- Contribute to regular reporting on achievements and challenges related to the project
- Participate in facilitating and coordinating activities within the team and with other DRC's departments
- Submit high quality analytical project weekly, monthly and quarterly progress reports against the work plan to the line manager with explanations of deviations from the work plan

## Capacity building

- Works with the Economic Recovery Manager to enhance capacity partners within the USAID YEA consortium
- Ensure that cross-cutting protection concerns are considered for all planned 480 interventions.
- Facilitate the continuous assessment process and provide support to staff conducting activities

- Support local partners in stakeholder coordination at field level to ensure intended programme outcomes

- Liaise with relevant technical line ministries during project implementation i.e. Ministry of Agriculture
