1.Who we are?

In the absence of the Supply Chain Technical Adviser he will deputize for the in country supply chain team's deliverable and performance with remote support from the Supply Chain Programme Manager, communications and reporting. He will ensure accountability and transparency across the supply chain in support of the Supply Chain Technical Adviser. Provides support to the Crown Agents teams as and when required.

The position will be based in Juba, South Sudan with some travel to support counties as needed.

4. Responsibilities

Client Relationship Management

With the in country Supply Chain Technical Adviser they will establish close collaboration with the Crown Agents Programme team to ensure programme planning, forecasting, delivering, monitoring, evaluating and continuous improvement.

Collaborates and provides support with the Supply Chain Technical Adviser in support to PR procurement team, distribution center's, Central Medical Stores (CMS) if relevant, the other programme stakeholders and other partners.

- Support the Supply Chain Technical Adviser in support to MOH, PR and partners on all 46 supply chain management issues related to malaria management.
- Identifies and promotes value-added services to the wider Crown Agents programme, MOH
- Actively promotes Value for Money through the timely delivery of the pharmaceuticals and medical supplies to the designated health facilities.
- Provides assistance on all aspects related to downstream and upstream supply chain flows
- Work closely with the Supply Chain Technical Adviser to provide assistance to the National Ministry of Health to ensure the effective and accurate collection and analysis of commodity

Operations Programme Management

- Working with the Supply Chain Technical Adviser in managing the Last Mile Distribution teams, ensuring timely collections of consignments from the respective warehouses/hubs at state/county level and delivery to the final health facilities in the designated States/Counties. They will be the interface between DFCA and National Security to get the clearance for road
- Assists appropriate planning, implementation, monitoring and evaluation of the Pick and Pack process within the designated warehouse in the supply chain operations. Assist the preparation of the required supply chain documentation and the accounting systems implemented by Crown Agents.
- Assists in monitoring the operational plans and ensures that any change is communicated appropriately, understood and accepted in a timely manner by the relevant parties.
- Provide assistance to supportive supervisory visits to the county stores, hospitalsand primary health care facilities to ensure drugs are properly stored and accounted for.
- Travels to medical warehouses, health facilities, MOH, PR and partners' when needed and assists with the assessment and recovery of the supplies.
- Attends the country National Technical Working Group meetings as directed by the Supply Chain Programme Manager and Supply Chain Technical Adviser.
- In the absence of the Supply Chain Technical Adviser works with Crown Agents Supply Chain Programme Manager, Supply Chain Logistics Director and Programme Director, to provide monthly progress updates, quarterly and end-of-assignment narrative reports as required.
- In the absence of the Supply Chain Technical Adviser maintains the supply chain risk register in alignment with and Crown Agents Supply Chain Programme Manager, Logistic Director and Programme Director.
- Assists the Supply Chain Technical Adviser in facilitating communication between states and the central level for commodity-related information, e.g., supply chain complaints resolution.
- Undertakes any other reasonable duties that may be required subject to mutual agreements with the various programme stakeholders as relevant.

5.Requirements

- Minimum 2-5 years of relevant experience and qualification (Degree level) in pharmaceutical management, Pharmacist preferred.
- Experience and understanding of supply chain in South Sudan essential
- Demonstrated success and understanding in working across cultural differences and the political and ethical issues surrounding public health issues among key populations
- Must be a local South Sudanese
