<u>CALL FOR PRE-QUALIFICATION OF SUPPLIERS, CONTRACTORS AND SERVICES PROVIDERS:</u>

Peace Winds Japan (Peace Winds) is a Japanese non-governmental organization (NGO) dedicated to the support of people in distress, and threatened by conflict, poverty, or other turmoil. With its headquarters in Japan, Peace Winds is engaged in emergency humanitarian relief as well as reconstruction and development assistance all over the world.

Companies, consultants and contractors that offer any of the following: supplies, services and works, are being sought.

C. CONSTRUCTION WORKS

D. CONDITIONS OF PRE-QUALIFICATION;

- Peace winds here in referred to as the organization requests applicants/candidates who
 meet the criteria set out by the organization below to apply for registration of prequalification.
- The pre-qualification objective is to supply and deliver assorted items, provided services and works under the relevant tenders/quotation to Peace Winds on and as when required during the stated period.
- Duly registered suppliers of goods and services under the laws of South Sudan are invited to submit their pre-qualification documents to Peace Winds so that they may be pre-qualified for submission of quotation. The prospective vendors are required to supply mandatory information for the pre-qualification.
- Prospective suppliers and contractors must have carried out successful supply and delivery of similar items, services and construction works to NGOs, etc. of similar size. Potential suppliers/Contractors must demonstrate the willingness and commitment to meet the pre-qualification criteria.
- This invitation of application for pre-qualification is open to potential applicants who are able to demonstrate proven technical, financial and managerial capacity to supply the listed goods, services and construction works.
- The successful applicant will be registered on Peace Winds suppliers and contractors list for the year 2024 and 2025 and the Peace Winds will only deal with the firms that are registered.

• Applicants must submit a duly completed and signed vendor registration form provided here in as Appendix "A".

• Peace Winds reserves the right to request for submission of additional information from



applicants or any other credible source, and to visit and inspect the business premises of the applicant to verify the information given.

- Peace Winds will ensure the information that is received from the companies is treated with utmost confidentiality and shall be for the sole use of the organization.
- The pre-qualified suppliers and contractors are required to immediately advise the organization of any significant change in its financial, technical capacity, ownership or holdings it may have.
- Failure to submit any of the mandatory requirements will lead to automatic disqualification from the exercise.
- Deadline to submit sealed application on or before 4th October 2024, at 4:00 PM South Sudan local time. Please drop sealed applications to Peace Winds office on the below Office address.

Companies already registered in Peace Winds database <u>MUST</u> re-submit their company information in order to be included in the updated database.

Companies will be expected to include copies of all certificates required by the Government of South Sudan from prospective bidders along with any other relevant documentation such as the ones listed in the pre-qualification evaluation criteria below.
