## BACKGROUND

Under direct supervision of Food Security and Livelihood Manager, the Agricultural Extension Supervisor will work direct with the County Administration, community members, local leaders and partner and will be responsible for the planning and overseeing the implementation of Food Security activities under the FAO project in Melut County.

## KEY RESPONSIBILITIES:

- 1. Key Result #1 -- Coordination and Representation (15%)
- Facilitate inception project processes and ensure all stakeholders are informed about the project.
- Represent FH in all related County level coordination forums and provide a summary update of related meetings to the FSL Manager.
- 2. Key Result #2 Take lead in project implementation (50%)
- Directly supervise Agriculture Field Extension officer ensuring they are receiving enough support to effectively deliver their roles in the field.
- Facilitate identification of project committees (AAP, PMC, SFC) and ensure they are
  effectively trained and understand their roles and responsibilities.
- Supervise the process of identifying beneficiary households using the target criterion as defined in the project document.
- Receive and account for livelihood inputs and ensure they are properly stored until they are distributed to the final beneficiaries.
- Facilitate the training of farmer groups as per provided guidelines.
- In consultation with the FSL Manager, lead in the day to day field operations, trouble shooting and making implementation decisions that ensure smooth project implementation.
- 3. Key Result #3 Reporting and record keeping (15%)
- Be accountable and safely keep all official documents generated at the county level including beneficiary registration records, distribution records, financial documents etc.
- Timely production of monthly updates and specific reports as required by the project like training reports, distribution summaries etc and forward these to the FSI manager timely the HUNGRY

Request cash advances to support project implementation and properly liquidate with enough support documents of the cash advance after use.
