- Support quality improvement team and the roll out of social accountability activities in the community, including youth

- Participate in and/or provide leadership to joint assessments, planning or other activities that involve coordination among health actors in the County; recommend appropriate future responses/partnerships/programming for IMA to pursue.
- In coordination with the CHD, Provide directsupervision of the local Health Workers, included those seconded by CHD/MoH, and to ensure they exercisehigh Standards of performance, adherence to the National (MoH) relevant Health guidelines and treatments protocols, conduct training needs assessment and support their capacity building efforts through tailored training to enhance their participation in the project, improve quality of care and lifesaving medical Health assistance to the affected/targeted communities.
- Coordinate with the County Health Department, (CHD/MoH) to ensure their involvement in the design of the programmes and overall leadership of the Healthcare management to ensure long-term sustainability and ownership of the Health activities.
- Reporting: Development and sharing of timely and quality project reports; including Weekly updates, as well as Monthly, Quarterly Indicator tracking, Mi-year and end of Project reports. Document challenges and lesson learnt, for contextual analysis.
- Attend County level coordination of project, with the consortium partner, CHD/MoH, UN and other INGOs.

- Oversee proper use and maintenance of facilities, assets, equipment and supplies owned or used by ESIR Project.
