Our development and humanitarian projects are part of a long-term Programme, where gender is a cross-cutting priority and community-driven activities, and capacity building of partners are the key components.

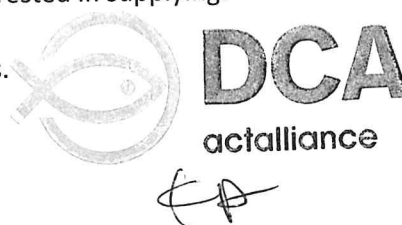
