## Purpose:

The overall purpose of this position is to see SAM cases with medical complications admitted in the SC; provide overall day-to-day leadership and management of the SC, OTP and TSFP at JAM's Nutrition side; and to provide support to the target communities in addressing specific health activities meant to improve access to quality and equitable health services to the PHCU's catchment area populations including supporting training/capacity building of the Nutrition site based staff.

## Major Responsibilities:

- See /attends to patients, administer requisite treatment and maintain up-to-date records of all transactions using provided registers and forms.
- Evaluation of child's medical and nutritional condition and ensure treatment for severe acute malnourished children with medical complication is in line with WHO management of SAM; a manual for physicians and other senior health workers protocol.
- Administer medical treatment to patients admitted in SC in accordance to 7 rights of medication administration
- Provide leadership in the stabilisation centre, OTP by ensuring proper protocols are used in the management of nutrition patients.
- Effectively following the SC protocols for the medical care of the SAM cases with complications.
- Monitoring progress of children being treated at the SC OTPs and TSFP
- Ensure nutrition beneficiaries medical follow-up at stabilization centre as well as OTP and TSFP sites.
- Ensure proper implementation of comprehensive Nutrition care in the SC, and OTPs with protocol and procedure in place.

 Supervise, motivate and train the junior Nutrition nurses and nutrition assistants SC, OTP and TSFP.

- Network and coordinate with the relevant units in the hospital
- Work closely with SC, Nutrition and IPD staff to ensure all SC protocols are understood and agreed and appropriate referrals take place to and from the OTP.
- Participate and disseminate public health and Nutrition health education messages to improve, attitude and practice of the community.
- Support in surveillance of epidemic-prone diseases and reporting accordingly.
- Order supplies and maintain updated supply/order forms (Bin Cards) and Inventories for the OTP and stabilisation centre.
- Produce timely weekly and monthly Stabilisation Centre reports.
- Conduct integrated nutrition outreaches in collaboration with the health team.
- Conduct weekly supervisory visits to all the outpatient therapeutic program {OTP}
- Carry out additional responsibilities and projects as assigned, including administrative and planning functions.

## **Key Qualifications:**

- Diploma in Nursing from a recognised institution;
- Working Experience in related field
- Knowledge and skills of CMAM and related programs in rural situations;
- General understanding of health service delivery, especially those related to women and Children;
- At least 2 years' experience working OTP, TSFP, SC;
- Proven analytical, problem-solving skills and comfortable working under minimal supervision;
- Highly organized, efficient, and able to meet key deadlines.
- Fluent in written and spoken English and Arabic
