

#### **ROLE PURPOSE:**

The Programme Coordinator is responsible for management and oversight of all of Save the Children's Child Protection and GBV technical interventions to address violations of children's rights and GBV in Mangalla IDP camp and ensure children and women are protected from abuse, exploitation, violence and neglect among internally displaced persons in Mangala IDP camp. The Programme Coordinator is responsible for ensuring quality programme activities at local level (in camps, entry points, and host communities - as per the specific location of assignment) and to develop the capacities of CP and GBVstaff and Local Authorities. The Programme Coordinator will be expected to lead on case management of individual Child Protection and GBV cases, oversight of psychosocial support activities for Child Protection and GBV cases, support community Child Protection and GBV Committees, technical training and capacity building to all CP and GBV staff and incentive workers, and coordinate with Child Protection and GBV partners at camp level in line with Child Protection and GBV Minimum Standards.

### KEY AREAS OF ACCOUNTABILITY:

Strengthen GBV, child protection and PSS response and prevention services

Provide strategic direction and guidance to the coordination group ensuring all relevant child protection and GBV needs are addressed;

Improve multisector coordination, increasing awareness of GBV prevention and mitigation.



Establish and strengthen of GBV referral services for the IDP community

Coordinate and collaborate with other players to do child protection and GBV assessments and ensure findings are documented and that all assessments include a specific analysis of children's and women's needs.

Provision of counselling and MHPSS services to ensure protection outcomes are

realized

- Work with the Protection Sector/GBV/Working Group leads to ensure key child protection and GBV concerns are reflected in Joint agencies and UNHCR-led multisectoral assessments, as well as other non-child protection and GBV-specific sectoral
- Ensure the capacity building of staff and volunteers in the following key technical
  - a) Support for psychosocial (physical, social, emotional) wellbeing of children , women and their families.
  - b) Utilization of tools within the Inter-Agency Child Protection and GBV Information Management System
  - c) Prevention and response to sexual exploitation and abuse (SEA) and genderbased violence (GBV)
  - d) Prevention and response to the main risks for children's and women's exposure to physical harm

e) Prevention and response to all forms of exploitation

- f) Integration of child protection and GBV into other core sectors
- Oversight of individual CP and GBV case management processes for every individual case in area of responsibility, including providing technical support regarding complex
- Oversight of compliance with agreed protocols (SOPs and ISP) and confidentiality of all case information including case files at camp level
- Oversight of all activities including weekly Minimum Standards Monitoring and ensuring action plan for improvements is implemented.
- With support from the Child Protection and GBV managers develop project monthly and quarterly plans for each specific camp.
- Produce weekly and monthly activity plans, and weekly and monthly activity reports, in line with planning of CP Officers and DIP.
- Ensure that the minimum standards of humanitarian relief are maintained in accordance with the Minimum Standards for Child Protection and GBV in Humanitarian Settings, the Sphere Charter and Red Cross Code of Conduct.
- Identify programme supplies needs and coordinate with the Supply Chain team to put in place a sensible phased procurement plan.
- Ensure that Save the Children's work is coordinated with efforts of other agencies and Government, and support Interagency Coordination forums including the Child Protection Working Group, GBV working group advocating for the specific needs of women and children. This may involve supporting the coordination of working groups and sub-working groups.

Contribute to communications and media work as required. Comply with Save the Children policies and practice with respect to Child Safeguarding, child protection, code of conduct, health and safety equal opportunities and other relevant policies and procedures.

Conduct timely, accurate and detailed reporting on any Child Safeguarding and GBV issues present at camp level - both within SCI programming and external to SCI interventions

## QUALIFICATIONS AND EXPERIENCE

- Education to Degree level in Social Work, Human Rights Law, International Relations, Development Studies or similar, or equivalent field experience.
- Prior experience of working within as an agency as a Programme Coordinator in an emergency response or fragile state OR participated with good results in the CP AoR CP coordination training or GBV training.

Previous experience of working in large-scale first phase emergency response

- Thorough knowledge of and experience in using the Minimum Standards for Child Protection and GBV in Humanitarian Action together with other established interagency standards and guidelines in child protection;
- Good knowledge of international human rights and humanitarian law, particularly concerning protection of IDPs and refugees;
- Extensive experience in capacity building and in strengthening various duty bearers understanding of and response to child protection and GBV;
- Demonstrated ability to set up monitoring & evaluation systems in large complex programmes;
- Experience of senior level representation;
- Experience of negotiating successful partnerships with institutional donors;
- Experience of working with and supporting government authorities and national NGOs;
- Excellent communication skills;
- Proven ability to influence change at an operational and strategic level;
- Politically and culturally sensitive with qualities of patience, tact and diplomacy;
- A high level of written and spoken English;
- The capacity and willingness to be extremely flexible and accommodating in difficult and sometimes insecure working circumstances;
- Commitment to and understanding of child rights and GBV and humanitarian standards such as the Sphere Charter and the Code of Conduct.
