# Organization background

Universal Network for Knowledge and Empowerment Agency (UNKEA), was established in 2002, to responds to the dire social, economic, livelihoods and health conditions experienced by people in conflict and other natural disasters within and outside South Sudan. UNKEA's initial purpose was to design strategies and interventions to fight the deadly Kalaazar disease which is highly prevalent in Upper Nile Region of South Sudan. With time, UNKEA's mandate expanded to include other interventions such as provision of primary health care services, nutrition, food security and livelihoods, water and sanitation, education; social development of youth and women; economic development, Access to Justice and peace building. UNKEA is registered with the Ministry of justice and RRC in South Sudan, Ministry of Justice, company act in Uganda and Charity, Society organisation in Ethiopia as a humanitarian non-governmental organization.

#### Project background

UNKEA is currently implementing a WASH project in Gogrial East County, Warrap State with funding from the Embassy of Japan in South Sudan. The project is constructing gender disaggregated pit latrines and installing a water harvesting system across 6 government health facilities. It is for this reason that UNKEA is seeking a qualified Engineer with broad experience in WASH constructions to supervise the ongoing construction works in the field.



## Essential Job duties / Scope of Work: Responsibilities of the WASH Engineer

- Supervision of WASH construction projects to ensure compliance with specifications, technical drawings, agreed quality standards and planned work schedules.
- Ensure all procured construction materials are in the right quantity and quality standards and delivered on time.
- Submit a supervision report on the ongoing construction works.
- The report should cover compliance to BOQ, quality and quantity of materials, quality of construction works, progress of construction works, etc.
- Report should also capture any claims by the contractor, weather conditions, accessibility of site etc.
- Report should include status well-being, health & safety of employees at the construction sites.
- The consultant shall demonstrate high levels of commitment to UNKEA values and policies to throughout the entire period of engagement with UNKEA.
- The consultant shall report on the contractor's respect to local cultural and gender sensitivity in the design of the Infrastructure- All latrines must be gender disaggregated with provision to aid persons with disability.
- Build positive working relationships with local communities, government officials, and other humanitarian representatives
- Take minutes of meetings to be organized between UNKEA and contractor.
- Prepare and submit construction Progress updates to UNKEA Juba HQs Office.
- The consultant shall abide by PSEA (Prevention of Sexual Exploitation and Abuse) standards
  within UNKEA and amongst beneficiaries served by UNKEA throughout engagement with
  UNKEA.
- Prepare a certificate of completion of work for the contractor.

- Inception reports including adaptation of monitoring tools and field trip plans
- Progress reports
- Inspection and Final reports

# Requirements (special training/experience required, provide 6-8 requirements): Minimum requirements are:

- Should have a minimum of Bachelors degree in Civil Engineering, WASH construction management or related fields of study
- Should be legally registered and licensed to operate in South Sudan.
- Should be affiliated to a legally registered constructions consultancy firm in South Sudan with a physical address in Juba.

- Should have at least 2 years' experience on WASH construction/supervision of building projects and water facility projects.
- Should be able to communicate fluently using oral or written English
