CALL FOR 2025 SUPPLIER PRE-QUALIFICATION

Program: SOUTH SUDAN

Malteser International is the international humanitarian relief agency of the Sovereign Order of Malta. For over 60 years we provide relief and recovery for people during and following conflicts and disasters around the world. Christian values and humanitarian principles form the foundations of our work. In over 30 countries in Africa, the Americas, Asia and the Middle East, we support people in need – regardless of their religion, origin or political convictions.

Malteser International has been working in the geographic area of today's South Sudan since 1996. MI implements a multi-sectoral program including Food & Nutrition Security, Livelihoods, WASH, health and peaceful conflict resolution. This includes activities such as agricultural trainings, cash distributions, food for education and access to water, sanitation and hygiene. The program is aiming to increase its work with local partner organisations to optimise its sustainability. Furthermore, MI applies a participatory, gender sensitive and inclusive approach in its programming. As of today, MI maintains its country office in Juba while operating a program office in Wau, Renk, Yei and project office in Uyujuku.

In accordance with the overall targets of above-mentioned operations, MI intends to refresh their supplier database for 2025 and invites suppliers and service providers registered under the Laws of South Sudan with offices in Juba, Wau, yei and Renk in respective goods and services to submit their preselection dossier to MI so that they may be considered for submission of quotations.

Applications must contain the following documents that are mandatory:

Legal documents

- Copy of the company's certificate of incorporation,
- Copy of valid Chamber of Commerce registration,
- Copy of valid Tax Identification Certificate,
- Copy of valid Certificate of Operation/Trading License/Business permit (Import & Export License, if applicable)
- Company's official address, phone number and email address,
- ID card/Passport of the owner or legal representative

Other required supporting documents:

- Standard Price List
- Duly signed preselection questionnaire,
- Company profile
- Product catalogue,
- List of clients (INGOs/UN agencies,)
- Terms of delivery and payment
- Current bank Statement of last three months,
- Relevant staff complement
- Testimonials or letters of references from at least 3 organisations

Applications will be evaluated according to the following evaluation criteria:

- Completeness of documents submitted,
- Proven experience and performance with INGOs/UN agencies,
- Proposed lead times
- Site visits to ascertain adequate storage facilities and availability of stocks in the supplier warehouse
- Standard terms of payment,
- Geographic presence
- Competitive Pricing

Suppliers or service providers who do not fulfil the minimum requirements, completeness of required documents will be excluded from the preselection of suppliers and service providers.

Whilst we appreciate the existence of general traders, each bidder can only express interest in not more than 3 of the listed categories. We prefer to consider specialised traders in the relevant fields. Bidders who apply for more than 3 markets will automatically be disqualified from the selection process.
