Conduct analysis, write reports, documenting investigation plans, results and follow- up on actions / recommendations.

#### **ROLES AND RESPONSIBILITIES:**

## **Coordinate Workplace Investigations**

• Lead and/ or conduct all assigned work place investigations (Safeguarding, fraud, misappropriation and abuse related investigations) in WV South Sudan offices in response to reported allegations on violations of WV policies or law. Conduct or support investigations relating to ethical misconduct and mismanagement as part of the staff disciplinary procedure.

# **Incident Management and Tracking**

• Prepare investigation Plans, conduct preliminary investigations.

- Prepare reports for approval by the People & Culture Director or her/his designee.
- Design and complete investigations tracker and dashboard and provide quarterly updates to the leadership.

# Incident analysis and evidence generation

- Together with the other assigned team members, analyze and evaluate data to provide facts regarding investigations.
- Provide conclusions and remedies to management based on investigative findings.
- Prepare reports with sufficient evidence as the basis for conclusion for review by the National Office IPH Team.
- Interpret and makes recommendations on investigation policies, procedures, practices and processes.

#### Coordination

- Supervise and guide other assigned investigation team members in zones and National Office in execution of the assigned investigation assignments.
- Training and capacity development
- Conduct on-going training on staff P&C and Finance policies and procedures and also provide technical guidance to other staff members nominated for investigations.
- Based on the request from leadership, conduct business process review of functions for effective quality and service delivery. Provide recommendations to the leadership for effective internal controls.
