#### A. SPECIFICATION OF BIDDING

Related to our advertised RFQ-WAU-2023-0020 Malteser International (MI) herewith calls for tenders for RFQ\_WAU\_2022\_0020 for Taxi hire services within Wau town with free waiting time of up to 30 minutes for 1 year framework agreement.

# Description of the organization and its activities

Malteser International is the worldwide humanitarian relief service of the Order of Malta and legally a division of Malteser Hilfsdienst e.V in Germany. It provides aid in all parts of the world without distinction of religion, race, or political persuasion. Christian values and the humanitarian principles of impartiality and independence are the foundation of its work.

In South Sudan, Malteser International operates in Juba, Yei, Wau and Rumbek. In these locations, its activities include Health and Nutrition, Food Security and Livelihood, Water Sanitation and Hygiene and Health Programs

**Objective of Request for Quotation:** In accordance with the overall targets of above-mentioned operations, MI plans to hire taxi services within Wau town under 1-year framework agreement for Malteser International Office in Wau.

The technical specifications and conditions of the quoting process are described below in the Specification of Quoting and in the Annex 2: Bill of Quantity which are part of this RFQ.

Service providers are invited to submit tenders complying with the requirements here below specified.

#### 1. Tender Presentation

The tender shall be received in sealed envelopes to Malteser International Office in Wau in Hai Daraja West Residential Area, Next to CARE International Office, North of St. Joseph Church, North Wau, Wau, South Sudan

# The deadline for the delivery of the tenders is: 20th February at or before 10:00AM.

- The tender shall be written in English.
- The envelope must state the following information:
  - ➤ Reference to the RFQ Number
  - Address to which the offer is being submitted (see above)
  - ➤ The words "Not to be opened before deadline" written in English.
- The offer should be valid for **60 days after the deadline.**
- The format BoQ can be used or a separate one depending on supplier's choice.

# 2. General conditions

- The tender shall be typed or written and signed on each page by the legal representative of the supplier,
- The winning company might be requested to provide catalogues, pictures, technical descriptions and/or samples of items at the order stage when required,
- The prices of the tender will be expressed in United States Dollars. The prices must be on unit price basis,
- The prices will be considered fixed whereas MI will not process Tax exemption. No additional change of whatsoever nature and type will be accepted by MI,
- MI reserves the right to accept or reject all tenders depending on prevailing condition at the time.
