



Tender for Construction of Dykes in Unity State Counties of Leer County, Panyijiar County and Mayendit County.

Notice to bidder's: World Relief International South Sudan is a Christian humanitarian organization that brings sustainable solutions to the world's greatest problems – disasters, extreme poverty, violence, oppression, and mass displacement. We partner with local churches and community leaders or Communities to bring hope, healing and transformation to the most vulnerable.

World Relief in collaboration with five consortium partners, including United Nations Mission in South Sudan (UNMISS), International Rescue Committee (IRC), Universal Intervention & Development Organization (UNIDOR), Dialogue and Research Institute (DRI), and Assistance Mission for Africa (AMA) is implementing the Southern Unity Area Based Program covering Leer County, Mayiendit County, and Panyijiar County. The program is funded by United Nations Multi-Partner Trust Fund in South Sudan for a period of three years (2024-2027).

Program Goal: To restore trust in peaceful conflict prevention and resolution mechanisms and set the community on the path towards resilience.

Nature of Notice: World Relief South Sudan is currently seeking for a suitable qualified/registered, experienced companies based in South Sudan with clean records of dyke's construction works to bid for construction of dyke in the three location, Leer, Panyijiar and Mayendit Counties of Unity state, Republic of South Sudan.

The construction will require **the simultaneous deployment of heavy machinery excavators** for earth moving and trench formation at all three sites.

Nature of Work:

	DETAILS	LOCATION OF THE TENDER
1	Provision of a total of 15 kilometers of flood protection dykes using heavy machinery, with 5 kilometers allocated per county. Each dyke will be built to a standard dimension of 2 meters in height and 3 meters in width.	Leer, Mayendit, Panyijiar Counties, Unity State, Republic of South Sudan

2. **Submission of bid documents:** The bid documents should be submitted in a sealed envelope indicating the above Tender reference and written "only to be opened in a Tender meeting on the **21st May 2025**" on the envelope to the following locations;
 - a. World Relief South Sudan, Country Office, Hai Cinema, Adjacent to National Ministry of Water and Irrigation Office, Republic of South Sudan.
 - b. Leer County World Relief South Sudan Field Office (humanitarian Hub)
 - c. Panyijiar County, International Rescue Committee (IRC), Located in Ganyiel.
 - d. Mayendit County, Universal Intervention and Development Organization (UNIDO) Field Office.
3. **Submission guidelines:** Upon submission of the bids, all bidders must register the company contact details in a bidder's log-sheet that may be found ready in any of the offices provided above, for bidders in Juba; **(DO NOT DROP YOUR BID INTO THE TENDER BOX WITHOUT REGISTRATION)**.
4. The bids should be submitted not later than **19th May 2025** during working days and hours (8:00am-5:00 pm) South Sudan local time. The Bids can only be submitted as a hand delivery to World Relief South Sudan offices mentioned above or through email submission.
5. **Bidders' eligibility:** For the bidders to be eligible to collect the bid documents, the bidder should be in conformity and in compliance to the Laws of the Republic of South Sudan and obtained a legal status, registration in the country as part of the requirements below;
 - Valid Certificate of Incorporation
 - Valid Current tax Compliance certificates
 - Valid Chamber of Commerce Membership Certificate
 - Valid Certificate of operations
 - Valid Trading licenses
6. **Scope of Work and Implementation Timeline**
 - **Construction Scope:** 15 kilometers of dykes (5 km per county) with standard dimensions of 2 meters high by 3 meters wide.
 - **Method:** Construction will be carried out using heavy machinery, which must be mobilized simultaneously across all three counties to ensure timely delivery.
 - **Implementation Period:** May 2025 to June 2025.
7. **Desired:** We prefer Companies that have previous experience in the location, possesses machinery available at the project site, and are capable of initiating activities simultaneously across all locations.
8. **Preferred:** Companies that can deploy machinery and begin activities simultaneously in all locations are also welcome to apply.


Closing date: The closing date for submission of completed bid documents is on **19th May 2025 at 5:00pm** South Sudan local time and any other documents submitted later than the mentioned time will not be accepted.
