PROVISION OF COURIER SERVICES TO AMREF HEALTH AFRICA IN SOUTH SUDAN

<u>April 2024</u>

1.0 Background information:

The South Sudan office is part of the global Amref Health Africa country program offices that emanated from Amref Health Africa corporate body founded in 1957 with its headquarters (HQ) in Nairobi, Kenya. Amref Health Africa's initial work in South Sudan focused on setting up and strengthening community based primary health care, development of human resources for health and strengthening health system.

Amref Health Africa in South Sudan head office is located at tong Ping, opp former UNOCHA Juba Central Equatoria State.

2.0 Objective

The objective of this procurement is to solicit a qualified service provider to Provide Courier services to Amref HA office in South Sudan.

Amref Health Africa is an Organization that is dependent on the budgetary and extra-budgetary donations and funds it receives for the implementation of its activities. Bidders are, therefore, requested to propose the best and most cost-effective solution to meet Amref Health Africa requirements, while ensuring a high quality of service.

3.0 Scope of work

Amref HA is seeking the services of a service provider with a proven record of providing courier services with the ability to track and maintain logs/records of all pick-ups and deliveries. Must have a system to track orders, delivery date and times, and proof of delivery.

The service will involve delivery of packages, equipment, documents etc across any Amref Office location worldwide to Juba as described.

3.2 Specific requirements of the provider

- Status The Company shall be an institution operating globally with proven expertise in logistics and haulage services.
- Accreditations Registration of the company with the relevant authority permitting logistics and haulage services in South Sudan
- Previous experience Previous work with other international organizations and/or major institutions in the field of courier services; Proven experience in providing courier services locally and internationally.

- Logistical capacity The company must have operational capacity to deliver within required timeframe. This requires global presence and/or representation in Amref HA operational areas. The Courier Company should have logistics capacity to coordinate these movements.
- Staffing The company must have qualified staff with logistics experience

4.0 Charges:

Contractor shall quote the cost for courier services and haulage with delivery at Amref HA offices in South Sudan.

5.0 Modification and Withdrawal of Proposals

The bidder may withdraw its proposal any time after the proposal's submission and before the submission deadline, provided that written notice via email of the withdrawal is received by Amref HA prior to the closing date.

No proposal may be modified after the closing date for submission of proposals, unless Amref HA has issued an amendment to the RFP allowing such modifications.

6.0 Evaluation of Proposals

A two-stage procedure will be utilized in evaluating the proposals, with technical evaluation of the proposal being completed prior to any focus on or comparison of price. The technical and financial evaluations of proposals will be accomplished by the tender committee. The tender committee will evaluate all proposals which have passed the Preliminary Examination of Proposals.

6.1 Technical Evaluation

- The technical evaluation of the proposals will include:
- The quality of the overall proposal, the appropriateness of the proposed approach, the quality of the technical solution proposed.
- Staffing The qualifications and competence of the personnel proposed for the assignment (logistics experience).
- Registration of the company with the relevant authority permitting logistics and haulage services in South Sudan or any other county of operation
- Experience Previous work with other international organizations and/or major institutions in the field of courier services; Proven experience in providing courier services locally and internationally.

- Logistical capacity The company must have operational capacity to deliver within required timeframe. This requires global presence and/or representation in Amref HA operational areas. The Courier Company should have logistics capacity to coordinate these movements.
- The contractor should also provide at least 3 referees details.

Technical Scoring and Weighting System: 60%

6.2 Financial Evaluation

During the Financial Evaluation, the price proposal of all bidders who have passed the Technical Evaluation will be compared, according to the following scoring and weighting system.

Financial Scoring and Weighting System: 40%
