

### About INTERSOS

# **Core Responsibilities**

The Livelihood Trainer will work under direct supervision of the Livelihood Expert and PM. In the framework of a project entitled "Provision of emergency NFI/shelter assistance to IDPs in response to the floods", the Livelihood Trainer will provide crucial operational and follow up support for all Livelihood related activities.

He/she will be responsible to:

#### Planning

- Draft monthly activity plan including its related financial requirements and submit to the Livelihood Specialist/PM using PAT tool;
- Draft BoQ and cost breakdown required for field level activity implementation including Market assessment, Beneficiary targeting, Livelihood Kit provision, PDM, Trainings, etc in collaboration with Livelihood Specialist/PM;
- Prepare periodic data collection plan including checklist and tools development in collaboration with Livelihood Specialist as per the project logframe indicators;
- Review and submit field mission requests or movements plans to the PM.

#### **Implementation**

- Engage on local basic commodity market mapping including its analysis through secondary data review and rapid assessment to inform project planned livelihood activities;
- Engage on beneficiary identification process through defining selection process, mobilization of stakeholders, leading the process being member of selection committee, etc in collaboration with Livelihood Specialist/PM;
- Engage on defining livelihood options to be supported informed by local market analysis, local economy and beneficiary consultation in collaboration with Livelihood Specialist/PM;
- Responsible on distribution of livelihood kits and delivery of various skill trainings for targeted beneficiaries;
- Conduct Post Distribution Monitoring (PDM) including preparation of the report in collaboration with Livelihood Specialist/PM;
- When needed provide translation services for expatriate staff to facilitate discussions and relations with communities;
- To make proper use and taking care of INTERSOS properties under his control.

#### Reporting

Draft/inform activity progress report every month and submit to the Livelihood Specialist/PM using PAT tool;

- Attend stakeholders meetings when needed at County/Payam/Boma level and report activities as instructed;
- Liaise with community members on projects implementation.
