JOB PURPOSE

The midwife will be responsible for providing safe, effective, and quality nursing care services for all the patients coming to the Mobile Clinic under the supervision of the Clinical Officer and Program Manager

Roles & Responsibilities

- Diagnosing, monitoring and examining women during pregnancy
- Developing, assessing and evaluating individual program of care
- Providing full antenatal care, including screening tests in nearby PHCCs, community and the home;
- Identifying high risk pregnancies and making referrals
- Arranging and providing parenting and health education for the woman, her partner and family members;
- Encouraging participation of family members in the birth to support the mother and enhance both mother/baby bonding and family relationships;
- Providing counseling and advice before and after screening;
- Offering support and advice following events such as miscarriage, termination, stillbirth, neonatal abnormality and neonatal death;
- Supervising and assisting mothers in labor, monitoring the condition of the fetus and using knowledge of drugs and pain management;
- Giving support and advice on the daily care of the baby, including breast feeding, bathing and making up feeds;
- Providing advice and guidance on a safe and timely transfer home;
- Liaising with agencies and other health and social care professionals to ensure continuity of care;
- Participating in the training and supervision of junior colleagues.
- Carry out any other duties as deemed necessary by the Clinical Officer or Program Manager





- Collecting and compiling accurate data to the Clinical Officer for final submission.
- Carry out any other related duties as deemed necessary by mobile clinic in charge.

KEY COMPETENCIES & ATTRIBUTES:

- Training in emergency obstetrics (e.g., Advanced Life Support in Obstetrics) and BEmONC.
- Ability to communicate effectively, both orally and in writing.
- Demonstrated ability to establish effective and cooperative working relationships built on trust.
- Excellent organizational and time management skills.
- Should be self-motivated
- Proficiency in computer skills, report writing and data collection using collection tools
- Should have good interpersonal and communication skills
- Ability to work under pressure with minimal supervision and independently in extremely remote locations.

MINIMUM REQUIREMENTS:

- Qualification as a Registered Midwife from recognized Institutions in East and Central Africa.
- At least 3 years of experience post-graduation in a known Maternity Unit (**preferably within Warrap State**).
- Valid Professional Practice License from Nursing Council
- Humanitarian aid work experience is an **added** advantage.
