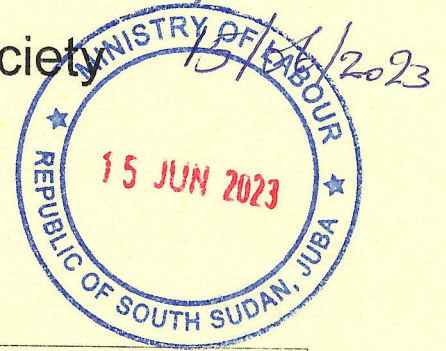

## INTRODUCTION

### Job Title: Community Mobilisers

**Job purpose:** With strong support and guidance from the Project Officer, Community Outreach Trainer will engage with local leaders and Community Protection Groups in secondary school communities with various activities geared toward mobilizing greater awareness, dialogue, and community-driven collective action to address barriers to girls' education, retention, and transition to higher institutions of learning. The position will require significant local travel to assigned project sites and communities.



## Key Accountabilities

- Establish relationships with community leaders and stakeholders in assigned project areas to introduce the initiative and to raise awareness about girls' education.
- Establish Community Protection Groups (CPG) in project areas.
- Undertake and deliver high-quality training to members of Community Protection Groups (CPG) in project areas.
- Monitor the progress of community training and support Community Protection Groups (CPGs) as they develop and implement their action plans to address barriers to girls' learning, retention, and transitions.
- Monitor the activities of Community Protection Groups (CPG) in project areas.
- Document and share impact stories in the communities with Project Officers.
- Ensure strong performance in line with agreed plans and budgets.
- Maintain strong communications with supervisors and project sites, ensuring the routine flow of information up from project sites and that all reporting requirements are met.
- To supervise and support School Mothers in the respective schools in the county.
- Additional duties as required.

## Person Specification

- Bachelor's degree or diploma in education, social work, international development, gender or development (equivalent additional training and experience will be considered);
- Minimum 2 years of experience with community-based facilitation.
- Experience with girls' education and/or gender and development is strongly preferred. Field experience in social and cultural context, especially as it relates to barriers to girls' education.
