Organizational Background

International Medical Corps is a global, humanitarian, nonprofit organization dedicated to saving lives and relieving suffering through health care training and relief and development programs. Its mission is to improve the quality of life through health interventions and related activities that build local capacity in underserved communities worldwide. By offering training and health care to local populations and medical assistance to people at highest risk, and with the flexibility to respond rapidly to emergency situations, International Medical Corps rehabilitates devastated health care systems and helps bring them back to self-reliance.

Summary of Responsibilities:

The Clinical Coordinator (Quality of Care Specialist) is responsible for overseeing and enhancing the quality management programs within the clinics. The role requires a Senior Nurse to leverage their clinical expertise to ensure the highest standards infection prevention, patient care, compliance with regulatory requirements, and continuous improvement in healthcare services. The tasks listed are representative of the nature and level of work assigned and are not necessarily all-inclusive.

ESSENTIAL JOB DUTIES / SCOPE OF WORK:

To perform this job successfully, an individual must be able to perform each essential function with or without reasonable accommodation. The tasks listed are representative of the nature and level of work assigned and are not necessarily all-inclusive.

- Ensure and organize medical activities at the supported facilities in accordance with MoH protocols and guidelines for beller quality services
- Jointly with the deputy medical coordinator, ensure and supervise implementation of protocols depending on project objectives.



- Ensure that proposed emergency RH interventions are guided by the MISP (Minimum Initial Service Package for RH in Crisis Situations), including the following services/activities: Facility deliveries, Emergency Obstetric Care (EMOC) or referrals for EMOC, Early neonatal care, Family Planning, Post-Abortion Care, Screening of blood donors and safe blood transfusions, Clinical Care for Survivors of Sexual Assault (CCSAS), antenatal and post-natal care service.
- Conduct regularly monitoring visit to assess the quality of the services deliver using a validated IMC check list
- Provide technical support to staff on the use of guidelines for better clinical management of patients
- Ensure the IPC measures with the universal hygiene standards taking into consideration quality and continuity of care are in place in all supported facilities
- Where feasible, ensure a 24-hour health service delivery system at the health facility
- Identify training to be conducted for health providers to ensure the quality of services provide
- Provide training periodically and on-job training that will ensure quality services for the benefit of other medical staff.
- Assist in the planning, coordination, facilitation and evaluation of QI learning sessions including curriculum, agenda, and faculty
- Demonstrate ability to make recommendations and implement quality improvement interventions based on results of projects.
- Converts data into useable information and measures the impact of improvement initiatives.

- Assures that quality improvement activities are documented and reported within the organization and externally as appropriate.
- Participate in compiling, analyzing and submitting health activities reports.
- Comply with IMC standard operational procedures and perform any other task requested by supervisor
